EXPLANATORY NOTE

This bill is a refiled bill which has reached the Senate in the 15th and 16th Congress. It was not enacted into law however due to events prevailing during those periods. It seeks to separate Ipil from its mother barangay, Bulanao, of the City of Tabuk, Province of Kalinga, to create a new barangay to be known as Barangay Ipil.

Ipil is already a regular barangay, having been created locally under Provincial Ordinance 2002-02 as amended by Provincial Ordinance No. 2003-013 which was ratified on December 22, 2002. Its corporate existence begun on January 20, 2003 when its first set of regular officials were elected, pursuant Section 14 of the Local Government Code of 1991.

The proposed barangay to be created under this bill shall compose of the following: Ipil, Mapaoay, Maledda, Matocnang, Sumadel and Dananao.

In view of the fact that barangay Ipil was locally created it could not be shared of the usual Internal Revenue Allotment (IRA) from the national government. The Provincial Government only shares a measly amount which is not enough to finance the delivery of basic services, much less provide the funds for infrastructure projects much needed by its residents. The conversion of Tabuk into a component city will definitely attract more population into this barangay; hence a great need for more funding to address its growing problems.

With this bill, it is highly expected that the new barangay of Ipil will no longer be encumbered by lack of funds, thereby enabling them to chart their own course for socio-economic development.

In view of the foregoing, the passage of the bill is earnestly sought.

**AN ACT CREATING A BARANGAY TO BE KNOWN AS BARANGAY IPIL IN THE CITY
OF TABUK, PROVINCE OF KALINGA**

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. *Creation of Barangay Ipil.*- Sitio of Ipil is hereby separated from Barangay Bulanao and constituted into a new barangay to be known as Barangay Ipil in the City of Tabuk, Province of Kalinga

SEC.2. *Conduct and Supervision of Plebiscite.* - The plebiscite conducted and supervised by the Commission on Elections (COMELEC) in Barangay Bulanao pursuant to Provincial Ordinance No. 2002-002 of the Sangguninang Panlalawigan of the Province of Kalinga in Barangay Bulanao, which ratified the creation of Barangay Ipil as proclaimed by the Plebiscite Board of Canvassers on December 21, 2002 shall serve as a compliance with the plebiscite requirement under Section 10 of Republic Act No. 7160, as amended, otherwise known as the "Local Government Code of 1991".

SEC. 3. *Incumbent Barangay Officials.* The incumbent barangay officials of Barangay Ipil shall continue to hold office until such time that their successors have been duly elected and qualified.

SEC. 4. *Public Infrastructure and Facilities.*- All existing public infrastructures and facilities for public use existing therein at the time of the approval of this Act are hereby transferred without cost or compensation to and shall be administered by the new barangay.

SEC. 5. *Internal Revenue Allotment Shares.*- Barangay Ipil shall be entitled to Internal Revenue Allotment (IRA) shares pursuant to Section 285 of Republic Act No. 7160, as amended, otherwise known as the "Local Government Code of 1991".

SEC. 6. *Effectivity.* - This Act shall take effect fifteen (15) days after its publication in the Official Gazette or in any newspaper of general circulation.
