EXPLANATORY NOTE

This bill seeks to establish a national elementary school in Barangay Tumana in the Second District of Marikina City to be known as the "Tumana National Elementary School".

At present, there is no existing public or private elementary school in Barangay Tumana. Students from this Barangay continue their education in other elementary schools in Marikina City. However, during enrollment period, these schools prioritize students coming from their localities, leaving students from Barangay Tumana waiting for admission to said learning institutions.

The establishment of a national elementary school in Barangay Tumana also seeks to lower the average student-classroom ratio of one hundred is to one (100:1) in the surrounding Barangays where they are forced to enroll and to increase the city's student participation rate in elementary school education. This will certainly help improve the quality of education in Marikina City, especially in the elementary school level.

In view thereof, the expedient approval of this bill is strongly recommended.

0	SECTION 1. Establishment of a National Elementary School. There is hereby

3	SECTION 2. Appropriations. The Secretary of the Department of Education shall
7	immediately include in the Department's program the operationalization of Tumana

	SECTION 3. Implementation. The Secretary of Education shall issue such rules
2	and regulations as may be necessary to carry out the purpose of this Act.
