EXPLANATORY NOTE


The 2013 Functional Literacy, Education and Mass Media Survey ("FLEMMS") covered around 36 million population aged 6 to 24 years. According to the survey, one in every ten or about 4 million Filipino children and youth was out-of-school in 2013. Out-of-school children is defined in the FLEMMS as persons aged 6 to 14 years who are not attending school while out-of-school youth as persons aged 15 to 24 years who are not attending school, have not finished any college or post-secondary course, and are not working.

The 2013 FLEMMS results also showed that of the nearly 4 million out-of-school children and youth, 22.9 percent have entered into union or marriage. Another 19.2 percent cited insufficient family income to send child to school as the reason for not attending school (this refers to all educational expenses other the tuition fee), while 19.1 percent lack he interest in attending school.

Another problem that continues to plague our nation is the fact that after graduation of our students, they often seek employment overseas instead of contributing to nation building. The reason normally is that there is a lack of opportunity in the Philippines and that of the promise of greener pastures in employment abroad.

This Bill now seeks to address this problem by mandating all students who receive full tuition grants and scholarships from the Government of the Philippines to render at least one (1) year of service for every year of free scholarship. This would be beneficial for both the student and the government as the grant would cover all expenses for the education of the student and in return the government will be assured that the student would remain in the Philippines and help in its development.

In view of the foregoing, the passage of this bill is earnestly sought.

AN ACT

MANDATING ALL STUDENTS IN STATE UNIVERSITIES AND COLLEGES (SUCS) RECEIVING SCHOLARSHIPS, GRANTS, OR SUBSIDY FROM THE GOVERNMENT TO RENDER AT LEAST ONE YEAR OF RETURN SERVICE IN THE PHILIPPINES FOR EVERY YEAR OF FREE TUITION/SCHOLARSHIP GRANT AND APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES

Be it enacted by the Senate and House of Representatives of the Republic of the Philippines in Congress assembled:

2 **SECTION 1. Short Title.** - This Act shall be known as the "*Mandatory Return Service*
3 *Law of 2017.*"
4

5 **SEC. 2. Declaration of Policy.** - The 1987 Constitution provides that "The State
6 recognizes the vital role of the youth in nation-building and shall promote and protect
7 their physical, moral, spiritual, intellectual, and social well-being. It shall inculcate in the
8 youth patriotism and nationalism, and encourage their involvement in public and civic
9 affairs."
10

11 Consistent with this Constitutional Principle, it is the declared policy of the State,
12 to ensure that its citizens whom it has provided free college and/or post-graduate
13 education, be required to render return service in the Philippines and contribute to the
14 development of the country.
15

16 **SEC. 3. Definition of Terms.** - As used in this Act, the following terms are defined
17 as follows:

18 a. *Government* - pertains to the Commission on Higher Education ("CHED")
19 or any other instrumentality of the Philippine government authorized by
20 law to grant scholarships, grants, or subsidy for tertiary or professional
21 courses/ degrees.
22

23 b. *Return Service*- refers to the rendering of one year of service for every

1 school year wherein the student/ beneficiary has received a full
2 scholarship, grant, or subsidy.
3

- 4 c. *Scholar*- includes all students enrolled in a State University or College
5 ("SUC") who are granted full scholarship, grant, or subsidy for a particular
6 school year.
7

8 **SEC. 4. Coverage.** – All students receiving full scholarship grant, subsidy, or any
9 other benefit whether directly or indirectly from the government of the Philippines
10 wherein the full tuition fee for the school year is completely paid shall be required to
11 render return service.
12

13 **SEC. 5. Scholarship.** – There shall be established a scholarship program for
14 qualified students seeking to obtain a college and/or post-graduate degree, which shall
15 be implemented by CHED with the concurrence of the various SUC's.
16

17 **SEC. 6. Qualifications of Student Beneficiaries.** – To qualify for the scholarship
18 grant, the beneficiaries must meet the following requirements, to wit:
19

- 20 i. He/she must be a Filipino Citizen.
21 ii. He/she must have completed his/her secondary education in a duly
22 accredited public school/institution in the Philippines.
23 iii. He/she must have maintained an exemplary academic and deportment
24 mark during his/her secondary education.
25 iv. He/she must be a resident of the Philippines.
26 v. He/she must maintain an above average grade to be determined by the
27 SUC.
28 vi. He/she must not commit any gross violation of rules and regulations
29 prescribed by the government and the SUC.
30

31 **SEC. 7. Requirements.** – The following conditions shall be imposed on the scholar,
32 to wit:
33

- 34 i. Upon completion of the college or post graduate course, the scholar must
35 render one year of service in a private institution or government agency
36 for every year of free tuition.
37 ii. The scholarship grant shall include free tuition and other school fees,
38 allowance for prescribed text books, supplies, and equipment, uniform,
39 housing and transportation accommodation, and other related
40 miscellaneous living allowances.
41 iii. If the scholar fails to finish the course, is kicked out, or drops out from the
42 program, he/she shall be liable to pay for the amount already granted.
43 iv. There shall be at least 5 students in every city and at least 10 students for
44 every province and highly urbanized city who shall be entitled to the
45 scholarship grant.
46

47 **SEC. 9. Implementing Rules and Regulations and Standard Forms.** - Within
48 sixty (60) days from the promulgation of this Act, the necessary rules and regulations for
49 the proper implementation of its provisions shall be formulated by the CHED in

1 collaboration with the Department of Education and all the SUCs.
2

3 **SEC. 10. Appropriations.** – SUCs, CHED, and the Department of Education shall
4 include in their annual budgets the necessary funds needed to implement the provisions
5 of this act.
6

7 **SEC. 11. Repealing Clause.** – All laws, ordinances, executive orders,
8 administrative orders, rules, regulations, decrees, and other issuances or parts thereof,
9 which are inconsistent with the provisions of this Act are hereby revoked, repealed, or
10 modified accordingly.
11

12 **SEC. 12. Separability Clause.** - If any provision of this Act is held unconstitutional
13 or invalid, the other provisions not affected thereby shall continue in operation and
14 remain in full force and effect.
15

16 **SEC. 13. Effectivity Clause.** - This Act shall take effect fifteen (15) days after its
17 publication in a newspaper of general circulation or the Official Gazette.
18
