House Resolution No. 899



Introduced by: **REP. SETH FREDERICK P. JALOSJOS AND REP. ARNOLFO TEVES, JR.**

A RESOLUTION TO INCLUDE ALL THE MEMBERS OF THE COMMITTEE ON DANGEROUS DRUGS IN THE HOUSE OF REPRESENTATIVES TO FUNCTION AS OVERSIGHT GROUP IN THE NEWLY CREATED PHILIPPINE NATIONAL POLICE (PNP) DRUG ENFORCEMENT GROUP (PDEG) FOR THE IMPLEMENTATION OF OPLAN DOUBLE BARREL RELOADED.

WHEREAS, the mandate of the **Committee on Dangerous Drug Drugs** provides: All matters directly and principally relating to illegal or prohibited drugs, controlled precursors and essential chemicals, the production, manufacturing, use and trafficking thereof, as well as the rehabilitation and treatment of drugs dependents,

WHEREAS, during the implementation of the **PNP OPLAN TOKHANG** to combat drug menace in the country was tainted with a negative public perception due to some members of the **PNP** rotten apples abusively used the **Oplan Tokhang** for their criminal activities such as kidnap for ransom, killing and planting of evidence that resulted for the disbanding of the then **PNP Anti Illegal Drug Unit**.

WHEREAS, the clamour of the **LGU's** nationwide that **PNP** should continue the **Oplan Tokhang** because unscrupulous drug operators have regained their strength to continue their illegal drug activities, upon which our beloved **President** has a marching order to the **PNP** to continue the said program.

WHEREAS, **PNP** has introduced a new program called **OPLAN TOKHANG 2** or **OPLAN DOUBLE BARREL RELOADED** and likewise, **PNP** has created a new unit **Philippine Drug Enforcement Group (PDEG)** task to handle this operation.

WHEREAS, with this new **PNP** drug enforcement unit for the implementation of **OPLAN TOKHANG 2**, the religious sector was invited to participate in this operation to make a credible implementation of this program.

WHEREAS, the created **OVERSIGHT GROUP** is task to monitor the day to day credibility implementation of the **OPLAN DOUBLE BARREL RELOADED** and weekly accomplishment report should be deemed necessary be available by the **Chairman of the Committee on Dangerous Drugs**.

WHEREAS, no amount or any emoluments be received or considered from the members of the Oversight group whether it maybe allowances derived from the PNP funds or from the House of Representatives.

NOW THEREFORE, Resolve as it is hereby resolved that all incumbent Members of the Committee on Dangerous Drugs be included in the implementation program of **OPLAN DOUBLE BARREL RELOADED** by the **PNP DRUG ENFORCEMENT GROUP (PDEG)** to function as **OVERSIGHT GROUP**, task to religiously monitor its operation to obtain check and balance for a credibility of its operations.
