				Under Section 378 of the Insurance Code of the Philippines, the "no-fault" indemnity claim provides that any claim for death or serious physical injury to any passenger or third party

Commissioner Dennis Funa of the Insurance Commission (IC) expressed support for the P50,000.00 increase since the total CTPL coverage is P100,000.00. He also informed the Committee that the "no-fault" indemnity claim was already adjusted to P15,000 in 2006.  Philippine Insurers and Reinsurers Association (PIRA) representative Cleto Obello disclosed that the association is working on increasing the CTPL coverage from P100,000 to P200,000 but with a corresponding increase in the premium amount.  The LTO, IC and PIRA were requested to come up with an affordable but comprehensive transport insurance scheme for all types of land vehicles.

				PDEA Deputy Director General Ruel Lasala reported that the four cylindrical magnetic lifters recently found in a warehouse in General Mariano Alvarez in Cavite were similar to the two cylindrical magnetic lifters seized at the Manila International Container Port (MICP) which had packs of shabu concealed inside. Lasala said traces of illegal drugs were detected in the four lifting equipment with the help of the sniffer dogs although no shabu was actually found in the said warehouse.
				On August 7, the BOC seized an abandoned shipment at the MICP containing two cylindrical magnetic lifters, which upon inspection, yielded about 500 kilograms of shabu, with a street value of P4.3 billion, hidden inside.
				Refuting Lasala's allegations, Customs Commissioner Isidro Lapeña asserted that the magnetic lifters could not have contained shabu because they tested negative for this illegal substance.

Dangerous Drugs				Suansing Jr. (2 <sup>nd</sup> District, Sultan Kudarat) asked PDEA to recant the earlier pronouncement of Director General Aaron Aquino that the four cylindrical magnetic lifters alleged to have been used to smuggle about 1,000 kilograms or a ton of shabu worth billions of pesos had allegedly slipped past the BOC.
				However, Lasala stood by the claim of the PDEA Director, citing circumstantial and documentary evidences PDEA has gathered. He requested that the names of the persons involved remain confidential so as not to jeopardize PDEA's ongoing investigation.
				Rep. Romero "Miro" Quimbo (2 <sup>nd</sup> District, Marikina City) opined that PDEA's assertions might have basis because the cylindrical magnetic lifters found at the MICP and in Cavite were clearly similar.
				Majority of the Members agreed that the BOC should be given additional budget for the implementation of its modernization and computerization programs in order to effectively stop the smuggling of contrabands into the country.

At the outset, Rep. Pimentel recounted that in the Committee's previous hearing, witness Roberto Catapang Jr. revealed the involvement of government officials in the alleged payments amounting to P8.7 billion to fake owners of properties in General Santos City that were subject of RROW acquisitions. He added that a certain Wilma Mamburam was the mastermind of this fraudulent right-of-way claims. Rep. Pimentel asked the resource persons to comment on this issue as well as to apprise the Committee of their respective findings concerning the case.
				Former DPWH Secretary Rogelio Singson denied his involvement in the incident, explaining that there was no legal basis for the accusation hurled against him and that he relied on the regularity of the documents submitted to his office during his term. Nevertheless, Singson disclosed that when he noticed that the payments made to the fake owners of titles in General Santos City were way above the usual payments for RROW acquisitions, he immediately ordered that the payments be stopped. However, the writ

Continuation Good Government and				of mandamus issued by the court in General Santos City compelled the DPWH to pay the remaining balance to the claimants.
Public Accountability				Land Registration Authority (LRA) Director for Legal Affairs Rhandolfo Amansec reported that based on the LRA's investigation on the matter, it found that more than 100 land titles involved in the RROW acquisition in General Santos City were spurious. He assured the Committee that the LRA has already identified the government employees and officials who were involved in the scam and promised to provide the Committee a copy of its findings.
				Department of Justice (DOJ) Assistant Secretary Sergio Yap II said that the DOJ has already filed cases of plunder and violations of the Anti-Graft and Corrupt Practices Act (RA 3019) against government employees and officials found to be involved in the alleged scam. The cases are now with the Office of the Ombudsman (OMB).
				Deputy Speaker Ferdinand Hernandez (2 <sup>nd</sup> District, South Cotabato) vouched for the integrity of former Secretary Singson. Rep. Hernandez also said that the sheer number of spurious land titles may reveal that the scam is a work of an organized syndicate which seems to have infiltrated the ranks of the bureaucracy. He advised the DOJ to look into similar cases outside General Santos City saying that he believes the same syndicate might be operating in the surrounding areas.
				The Committee Secretariat was instructed to invite the judge who issued the writ of mandamus and the DPWH employees who represented the Department in the case. Likewise, the DPWH was asked to submit to the Committee all its releases for RROW from the years 2010-2017.
				The Committee will issue a subpoena to Mamburam and a certain Nelson Ti who is allegedly her accomplice to comment on their alleged involvement in the scam.

On the other hand, Rep. Evelina Escudero (1st District, Sorsogon), author of HB 6113, maintained the need to create a separate Department of Culture (DOC) which will be mandated to develop, manage and implement policy and strategic decisions in the promotion of Filipino culture.

Similarly, Rep. Christopher V.P. de Venecia (4<sup>th</sup> District, Pangasinan), author of HB 6260, said that the envisioned Department shall comprise bureaus with different focus areas promoting and preserving Filipino cultural identity and heritage. He added that culture and heritage not only play an important role in the social transformation of an individual but also in the economic advancement of a country, adding that the Philippines' creative industries contribute about 5% to the total gross domestic product (GDP) of the country.

Bernan Joseph Corpuz, division chief of Plan/Policy Formulation and Programing Division, National Commission for Culture and the Arts (NCCA), presented the agency's position favoring the creation of a separate Department of Culture. He emphasized the need to have a lead government body that will coordinate efforts at promoting national identity which is essential in providing the nation with a strong sense of direction and order of priorities.

Komisyon sa Wikang Filipino (KWF) Director General Anna Katarina Rodriguez also favors the creation of a DOC saying that right now, it is the NCCA which acts as the policy making and coordinating body on the preservation, development and promotion of culture and the arts. However, she said that the different implementing agencies are attached to various Departments which makes coordination and synergy in program implementation difficult and weak.

Like its usual stand on creating additional layers in the bureaucracy, the Department of Budget and Management (DBM) opposes the creation of another department to handle culture and the arts. DBM's Systems and Productivity Improvement Bureau Director Clotilde Drapete said that strengthening the mandate of the NCCA is a better alternative, stressing that creating a new department will require at least P1 billion budget while reorganizing and creating a bureau will require only about P18 million for personnel services.

The DBM was requested to submit a budget estimate for the creation of a department versus the creation of a bureau in an existing department.

Representatives from DepEd will be invited to attend the Committee's next meeting.
