SPONSORSHIP SPEECH OF REP. CAYETANO

REP. CAYETANO. Thank you, Mr. Speaker.

Mr. Speaker and honorable colleagues, I stand before you today to sponsor House Bill No. 7185 under Committee Report No. 610, entitled: AN ACT RECOGNIZING THE FOREIGN DECREE OF TERMINATION OF MARRIAGE AND ALLOWING ITS SUBSEQUENT REGISTRATION WITH THE PHILIPPINE CIVIL REGISTRY, AMENDING FOR THE PURPOSE EXECUTIVE ORDER NO. 209, OTHERWISE KNOWN AS THE FAMILY CODE OF THE PHILIPPINES.

As a background, this Bill was approved unanimously by the Committee on Population and Family Relations last January 31, following a series of consultations held by the Committee with Filipino communities in Hong Kong, Japan and Malaysia, and our public hearings here in the House of Representatives.

Mr. Speaker, our Family Code recognizes the right of a Filipino married to a foreign spouse to start over if their marriage fails, but our consultations in Hong Kong, Tokyo, and Kuala Lumpur revealed that the current process has not made this possible for many of our fellow Filipinos

Imagine this scenario: you are married to him but he is not married to you. Imagine that. There is so much difficulty in filing a case when one is working abroad and that makes it next to impossible. I am talking about a scenario where a Filipina is already divorced by her foreign spouse. The law currently allows this Filipina to file a case for judicial recognition back home, but it is extremely difficult. Not only are there major cost implications, but the entire process of hiring the services of a local lawyer, preparing the documents, attending the hearing— all of these make it extremely hard for Filipinos living abroad to undertake. We also discovered that it is just as difficult for many Filipinos living here, married to someone but, as I have said, who does not consider himself or herself married to the other. This measure seeks to make simpler the process of having foreign divorce decrees recognized in our Civil Registry.

Under our Family Code, the divorced Filipino spouse needs to petition a Philippine court to acquire judicial recognition of his or her foreign divorce decree and have the same entered in the Philippine Civil Registry. Only at this point can the Philippine Statistics Authority issue a Certificate of No Marriage for the said person. This Certificate of No Marriage is a basic requirement before he could be capacitated to remarry under the Philippine law.

Under House Bill No. 7185, the Filipino spouse, upon obtaining the Decree of Termination of Marriage,

shall submit for authentication the document to the nearest Philippine Embassy or consular office in the country where the decree was issued. The Philippine Embassy or consular office will then send the authenticated document to the Department of Foreign Affairs, the Office of Consular Affairs, and the Consular Records Division for transmittal to the Philippine Statistics Authority. Finally, the Philippine Statistics Authority will process the annotation of the marriage certificate and issue an advisory on the annotation. In short, the Bill does away with the current lengthy, tedious and financially burdensome process of judicial recognition, replacing it with a faster, easier and cheaper administrative process.

Lastly, Mr. Speaker, I would like to share with the Members of this Chamber that this Bill is truly a product of the numerous consultations we had with our kababayans. Their insight and stories that they openly shared with the Committee, helped us to craft the provisions of this measure that we are presenting to you today. I urge my honorable colleagues to listen to the voice of our people who count on us to pass laws that apply to them, that are meaningful to them, and that would protect their interests and rights.

Thank you, Mr. Speaker and honorable colleagues. I am ready for interpellation.
