AN ACT
ESTABLISHING A LAND TRANSPORTATION OFFICE (LTO) DISTRICT
OFFICE IN THE CITY OF SIPALAY, PROVINCE OF NEGROS OCCIDENTAL,
AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. There shall be established a district office of the Land Transportation Office (LTO) in the City of Sipalay, Province of Negros Occidental.

Sec. 2. The Secretary of the Department of Transportation (DOTr) shall immediately include in the Department's programs the operationalization of the LTO District Office in the City of Sipalay, Province of Negros Occidental, the funding of which shall be included in the annual General Appropriations Act"

Sec. 3. The Secretary of the DOTr shall issue rules and regulations necessary for the effective implementation of this Act within sixty (60) days from effectivity of this Act.

Sec. 4. This Act shall take effect fifteen (15) after its publication in the *Official Gazette* or in a newspaper of general circulation
