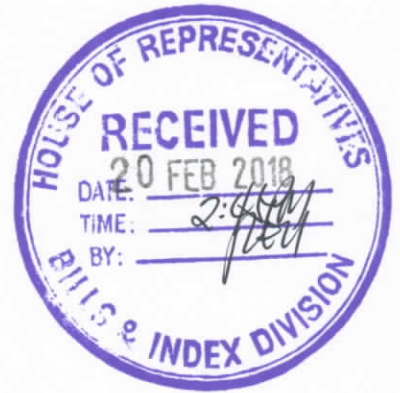

**RESOLUTION**

**COMMENDING THE SAN DIONISIO CREDIT COOPERATIVE (SDCC) FOR ITS PIONEERING COOPERATIVISM IN THE COUNTRY AND FOR ITS OUTSTANDING LEADERSHIP AND ACHIEVEMENTS IN THE ECONOMIC UPLIFTMENT OF ITS MEMBERS AND ITS CONTRIBUTIONS TO NATIONAL DEVELOPMENT**

**WHEREAS**, the San Dionisio Community Cooperative (SDCC) was organized and founded on July 28, 1961 in Barangay San Dionisio, Paranaque City by members of the Rover Scouts who envisioned a strong, economically viable, service-oriented cooperative association responsive to the economic needs of its members and dedicated to the upliftment of their standard of living by instilling thriftiness and the intelligent use of credit and money;

**WHEREAS**, the SDCC is guided by time-tested cooperative principles and practices manifested through wise financial counseling and continuing education to develop in its members the values of self-reliance, initiative, integrity and cooperation.

**WHEREAS**, the paramount focus of the SDCC is "COOP Education" following its guiding principle that "a cooperative starts with education, expands through education, controlled through education and its success depends largely on education";

**WHEREAS**, the SDCC has successfully implemented beneficial programs such as the Business Employment, Education and Food (BEEF) Program which identifies marginalized cooperative members and determines how to help them; the Alternative Learning System (ALS) which grants scholarship benefits to poor and deserving students, the Supply Chain Initiative which connects producers to the consumers, and the Safe Haven, Environment Protection, and Holistic Emergency Response to Disasters (SHEPHERD) Committee which empowers its members and their respective communities on disaster preparedness and response;

**WHEREAS**, the SDCC has proven through the years that its efforts and services have greatly improved the economic well-being of its members and the community where it operates in;

**NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the House of Representatives to commend the San Dionisio Community Cooperative (SDCC) for pioneering cooperativism in the country and for its outstanding leadership and achievements in the economic upliftment of its members and its contributions to national development.
