The Committees on Justice and Appropriations, to which was referred House Bill No. 3113, introduced by Rep. Lianda B. Bolilia, entitled:



AN ACT

CREATING ONE (1) ADDITIONAL BRANCH OF THE REGIONAL TRIAL COURT IN THE FOURTH JUDICIAL REGION TO BE STATIONED IN THE MUNICIPALITY OF ROSARIO, PROVINCE OF BATANGAS, AND APPROPRIATING FUNDS THEREFOR, AMENDING FOR THE PURPOSE SECTION 14(E) OF BATAS PAMBANSA BILANG 129, OTHERWISE KNOWN AS 'THE JUDICIARY REORGANIZATION ACT OF 1980', AS AMENDED

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** One (1) additional branch of the Regional Trial Court to be stationed in
2 the Municipality of Rosario, Province of Batangas, is hereby created in the Fourth
3 Judicial Region.

4
5 The Supreme Court shall assign the branch number for the newly-created branch of
6 the Regional Trial Court.

7
8 **SEC. 2.** The Chief Justice of the Supreme Court, in coordination with the Secretary
9 of the Department of Justice, shall immediately include in the Court's program the
10 operationalization of the additional branch of the Regional Trial Court to be stationed in
11 the Municipality of Rosario, Province of Batangas, the funding of which shall be
12 included in the annual General Appropriations Act.

14 **SEC. 3.** Section 14(e) of Batas Pambansa Blg. 129, otherwise known as "The
15 Judiciary Reorganization Act of 1980", as amended, and all other laws, rules and
16 regulations that are inconsistent with this Act are hereby amended, repealed or
17 modified accordingly.

19 **SEC. 4.** This Act shall take effect fifteen (15) days after its publication in the *Official*
20 *Gazette* or in a newspaper of general circulation.
