

AN ACT
RENAMING DEL MONTE AVENUE, TRAVERSING BARANGAYS NAYONG KANLURAN, PALTOK, PARAISO, DEL MONTE, DAMAYAN, MASAMBONG, TALAYAN, MANRESA, SIENA, ST.PETER, SAN JOSE AND N.S. AMORANTO, LOCATED IN LEGISLATIVE DISTRICT I OF QUEZON CITY, AS FERNANDO POE JR. AVENUE

Be it enacted by the Senate and the House of Representatives in Congress assembled:

SECTION 1. The Del Monte Avenue, traversing Barangays Nayong Kanluran, Paltok, Paraiso, Del Monte, Damayan, Masambong, Talayan, Manresa, Siena, St. Peter, San Jose and N.S. Amoranto, located in Legislative District I of Quezon City, is hereby renamed as Fernando Poe Jr. Avenue.

SEC.2. The Department of Public Works and Highways shall issue the necessary rules, orders, and circulars to implement the provisions of this Act within sixty (60) days from its effectivity.

SEC.3. This Act shall take effect fifteen (15) days after its publication in the Official Gazette or in a newspaper of general circulation.
