1. Voting in the affirmative, Rep. Kaka J. Bag-ao said that she was in favor of continuing and strengthening the 4Ps which had a good effect on her constituents in Dinagat Islands. She added that House Bill No. 7773 had to be enacted in order to address poverty more thoroughly and to ensure that those whom government will assist are those who need it most.
2. Even as Rep. Emmi A. De Jesus acknowledged the need for a bridge to the other side of poverty, she asked whether the 4Ps was long-term and sustainable. She opined that a measure that appropriates big funds to an uncertain program, amidst the reality of employment difficulties among new graduates and a decreased budget for education in the 2019 proposed national budget, will only worsen the plight of the poor and institutionalize poverty. She added that until the 4Ps is fully evaluated, she will vote against House Bill No. 7773.

The session resumed at 4:49 p.m.

#### **UNFINISHED BUSINESS: COMMITTEE REPORT NO. 818 ON HOUSE BILL NO. 8083**

On motion of Representative Defensor, there being no objection, the Body resumed consideration on Second Reading of House Bill No. 8083 contained in Committee Report No. 818 as reported out by the Committees on Ways and Means, and Appropriations.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

“AN ACT AMENDING SECTIONS 4, 5, 20, 22, 27, 28, 34, 40, 50, 73, 112, 117, 119, 204, 222, 237, 237-A, 255, 256, 257, 258, 260, 261, 262, 263, 264, 265, 266, 275, 288, 290 AND ADDING SECTIONS 6-A, 282-A, 291, 292, 293, 294, 295, 296, 297, 298, 299, 300, 301, 301-A, 301-B, 302, 303, 304, 305, 306, 307, 308, 309, 310, 311, 312, 313, AND 314 UNDER THE NATIONAL INTERNAL REVENUE CODE OF 1997, AS AMENDED, AND FOR OTHER PURPOSES.”

Representative Defensor stated that the parliamentary status was that the Bill was in the period of sponsorship and debate; and on his motion, the Chair recognized Rep. Estrellita B. Suansing, one of the authors of the Bill, to sponsor the measure, and Rep. Romero “Miro” S. Quimbo for his interpellation.

#### **INTERPELLATION OF REPRESENTATIVE QUIMBO**

Initially, Representative Quimbo inquired how he was addressed by the Majority Leader. The Chair responded that he was addressed as the Gentleman from Marikina, not a majority nor a minority. Pending the decision of the Supreme Court on the case which he had filed, Representative Quimbo said he would accede to the ruling of the Chair.

Representative Quimbo then exchanged views with Representative Suansing (E.) regarding the number of new jobs to be generated from the Bill; how the micro, small and medium enterprises (MSMEs) will benefit from the proposed lower corporate income tax; and if these MSMEs are currently tax compliant.

Representative Quimbo next discussed about the country having the highest effective tax rate in the ASEAN for corporations and opined that this might be one of the reasons companies do not actually come to the Philippines. He thereafter asked about the sequence of the lowering of the tax rate from the current 30 percent over a five-year period; how many jobs will be generated for every year if the corporate income tax is lowered considering the measure is called the Tax Reform for Attracting Better and High-Quality Opportunities or the TRA-BAHO Bill.

Representative Suansing (E.) replied that the Committee does not have the figures and pointed

out that it would be difficult to estimate the job opportunities because there are other factors that should be considered. The Sponsor also pointed out that they do not foresee any job losses and stated that they are even expecting more savings because the reduction of income tax will translate to increase in salaries.

Representative Quimbo thereafter discussed with the Sponsor how tax incentives might result in job losses and stop business expansion, but the latter explained that projections on the effects of the measure could be realized only after its implementation. They also focused on the revenue targets and achievements of Package 1 of the Tax Reform for Acceleration and Inclusion or TRAIN 1 Law. Representative Quimbo asked for a breakdown of the projected ₱90 billion revenue.

#### **SUSPENSION OF SESSION**

On motion of Representative Quimbo as seconded by Representative Defensor, the session was suspended at 5:12 p.m.

#### **RESUMPTION OF SESSION**

The session resumed at 5:15 p.m.

#### **INTERPELLATION OF REPRESENTATIVE QUIMBO** (Continuation)

Upon resumption of session, Representative Suansing (E.) said that it was difficult to give a revenue breakdown of TRAIN 1 because other factors like the efficiency of the Bureau of Internal Revenue (BIR) and economic growth, make it hard to distinguish between TRAIN and non-TRAIN revenues. Representative Quimbo however asked how Congress could determine whether its tax measure is effective or not if there is no scorecard to base it on.

Thereupon, Representatives Quimbo and Suansing debated on the effects of the tax incentives given to nonprofit educational institutions and hospitals in case they could not comply with the established performance criteria determined by the Commission on Higher Education (CHED), and the Departments of Education (DepEd) and Health (DOH). Then focusing on the tax incentives given to higher educational institutions (HEIs), both Members delved on the impact on the tuition fees charged by the HEIs as they would pay higher taxes in case they would not qualify with the established performance criteria.

Representative Suansing stated that there would be a voucher system that will absorb the tuition fee increases but Representative Quimbo pointed out that the voucher system does not in any way encourage the HEIs to upgrade their standards. He stressed that the CHED should use its regulatory function to address the matter. The Sponsor maintained that the proposed measure will encourage HEIs to level up their standards in order to qualify with the established performance criteria.

Representative Quimbo then inquired whether proper consultations were made with different stakeholders such as the CHED and the concerned schools. He also expressed concern that 1) changing the tax regime of hospitals would have a negative effect on the country's already mean social health institution, 2) the government would not be incentivizing but rather rewarding hospitals even if they increase the medical expenses but still provide poor quality of service to their patients, and 3) the voucher system which was similar to those given to college students are simply buffers for shocks on a likely increase in medical expenses that would not be beneficial especially to indigent patients.

Representative Quimbo stated for the record that relevant data should be made available to the House Members, the Bill being an important tax measure.

Seeking for commitment that the four main pillars of the social pension fund such as the Pag-IBIG Fund, Social Security System (SSS), Government Service Insurance System (GSIS), and Philippine Health Insurance Corporation (PhilHealth) were fairly considered in the proposed measure in terms of tax payments and exemptions, Representative Quimbo particularly asked about the rule and performance standards for socialized housing and how housing companies would be provided with appropriate tax privileges and incentives.

#### **REMINDER FROM THE CHAIR**

At this point, the Chair called the attention of Representative Quimbo regarding his time on the floor.

#### **INTERPELLATION OF REPRESENTATIVE QUIMBO** (Continuation)

Winding up his interpellation, Representative Quimbo noted that the proponents of the instant Bill failed to consider and were not fully aware of the possible negative impact of the instant Bill on the livelihood, education, health, and housing concerns.

On motion of Representative Defensor, the Chair recognized Rep. Mark O. Go for his interpellation.

#### **INTERPELLATION OF REPRESENTATIVE GO (M.)**

Representative Go initially posed a question about the reduction of corporate income tax and how the government could recover the possible losses to be incurred in the succeeding years. He then discussed with Representative Suansing (E.) the several indicators in determining nonperforming proprietary schools and hospitals.

Representative Suansing explained that the government had already established the performance standards which aim to improve the quality of education and teachers, and merely needed to monitor compliance therewith.

*At this point, Deputy Speaker Garin (S.) relinquished the Chair to Deputy Speaker Mercedes K. Alvarez.*

Subsequently, the two Members debated on projected revenue collections or losses as a result of the implementation of the instant Bill.

Representative Suansing said that the measure is revenue-neutral and the government does not know how many companies will retain incentives or qualify for new incentives. Representative Go stressed that it will be hard to determine if the Bill is a good measure or if it will be able to help fund the proposed national budget, given this lack of data and statistics.

*At this juncture, Deputy Speaker Alvarez (M.) relinquished the Chair to Deputy Speaker Garin (S.).*

The Sponsor assured Representative Go of a copy of pertinent information once it becomes available.

Representative Go asked whether the Sponsor was aware that the tax collection of the government would be reduced once the tax rate is lowered. After being provided with projections on revenue losses and earnings of the government as a result of the proposed reduction in corporate income taxes, Representative Go said that he will accept the estimates given by the Sponsor for the time being and thereafter ended his interpellation.
