With 220 affirmative votes, nine negative votes, and no abstentions, the Body approved on Third Reading House Bill No. 6215.

RESULT OF THE VOTING, AS AMENDED

Whereupon, Majority Leader Fariñas and Rep. Juan Pablo “Rimpy” P. Bondoc informed the Body that Reps. Manuel Luis T. Lopez, Abigail Faye C. Ferriol-Pascual, and “Kuya” Jose Antonio R. Sy-Alvarado wished to have their “Yes” votes registered in the approval on Third Reading of House Bill No. 6215 or the 2018 General Appropriations Bill (GAB).

In view thereof, Chair directed the Secretariat to reflect into the records the total number of affirmative votes at 223 instead of “220.”

EXPLANATIONS OF VOTE

The following Members explained their votes:

1. Rep. Gary C. Alejano initially said that although the national budget aims to spur

- development and provide employment for the poor, it funds the war against illegal drugs; finances agencies that fail to fulfill their mandate; does not include the restoration of the budget of the Commission on Human Rights (CHR); and disregards the constitutional mandate of protecting national interest and the territorial integrity of the country. He also criticized the low allocation for the Armed Forces of the Philippines (AFP) that could affect its capacity to ensure national security.
2. Speaking in Filipino, Rep. Arlene D. Brosas stated that she was against House Bill No. 6215 because it will not provide for relocation or housing programs, employment opportunities, and safeguards against higher taxes but allocates billions of funds for Build, Build, Build (BBB) projects. She further denounced the fact that it decreases the budget for health services and education but augments funds for Oplan Double Barrel that promotes violence and human rights violations.
 3. Also speaking in Filipino, Rep. Ariel “Ka Ayik” B. Casilao expressed his opposition to the measure because it does not address fundamental issues concerning land, development, wage, housing, human rights, and basic services; and allocates less than one percent of total funds to the Department of Agrarian Reform but billions of funds to the AFP and Philippine National Police (PNP). He added that it slashes the budget of the CHR; and allocates huge funds for BBB projects that will protect the interest of foreign monopolies.
 4. Rep. Gabriel H. Bordado Jr. expressed his support for the measure and commended the House leadership for the ₱40 billion budget for the implementation of the Universal Access to Quality Tertiary Education Act. However, he expressed hope that the budgets of the CHR and public hospitals will be restored to their original amounts.
 5. Rep. France L. Castro stated that she was against the measure because it entails new loans as well as new taxes, to the detriment of political and economic sovereignty and the interest of the citizens of the country. Speaking in Filipino, she also expressed concern about the budget cuts for basic social services, health, education, and salary increases for government workers. She rued the fact that more funds were instead allocated to pro-oligarch and pro-comprador projects as well as anti-people programs.
 6. Rep. Emmi A. De Jesus voted against the approval of House Bill No. 6215 because she believed that it was not transformative and consistent with the President's budget message and vision of a strongly-rooted, comfortable, and secure life for all Filipinos. Speaking in Filipino, she held that the national budget was based among others, on a neoliberal paradigm, new taxes, privatization, BBB projects, Oplan Double Barrel Reloaded, and automatic appropriations. Meanwhile, she lamented, it was insensitive to the health and housing concerns especially of the poor as well as for women's rights to social services and protection.
 7. Rep. Raul V. Del Mar registered his "Yes" vote despite his disapproval over the move to slash the CHR budget, saying that it was not only capricious but unconstitutional. He emphasized the importance of strengthening institutions and not weakening them. He requested Congress to support and restore the original budget of the agency to enable it to fully exercise its constitutional mandate.
 8. In explaining her negative vote, Rep. Sarah Jane I. Elago said that the 2018 GAB not only kills the national economy by being pro-big business; but also kills the people by allotting billions of funds for the war on drugs. She added that it is anti-poor, has not provided enough for the needs of state colleges and universities as well as basic social services, and is prone to corruption due to lump sum and discretionary appropriations as well as provisions on impoundment. She suggested the realignment of funds to human rights protection, land reform and national industrialization, and other socio-economic projects.
 9. Voting in the affirmative, Rep. Edcel C. Lagman acceded that the government needs a national budget for 2018 but expressed strong reservations on the reduced budget of the CHR which was yet to be restored. He pointed out that with a

slashed budget, the agency will not be able to promote its advocacy for human rights protection and promotion and implement its programs thereon.

10. Speaking in Filipino, Rep. “Kuya” Jose Antonio R. Sy-Alvarado voted “Yes” to House Bill No. 6215 because of his firm belief in President Rodrigo Roa Duterte’s capability to manage well the country’s budget but stressed that there were other areas that need increased budget such as flooding, education, and proper housing for the people.
11. Rep. Antonio L. Tinio said he posed an objection to the voting process done on Third Reading of House Bill No. 6215 because the House Majority did not even inform the Body on the amendments made on the Second Reading version. Speaking in Filipino, he stressed that he was voting against the measure for the following reasons: it was a budget that will benefit mostly businessmen and landlords and their foreign partners; it did not solve the widespread poverty problem, but widened the gap between the rich and majority of the poor; will worsen the inequality of the society’s social ladder because less funds was allotted for decent and cheap housing, barangay roads, clean water and sanitation for everyone, cheap electricity and telecommunications (including the internet); it kept the congressional pork barrel and the presidential pork barrel; it will fund the war against the Moro people, the war on drugs that caused thousands of extrajudicial killings (EJKs) among the urban poor, and the war against poor peasants, indigenous peoples, and indigenous peoples throughout the countryside; and it reduced the CHR initial budget. He pointed out that only development through genuine agrarian reform and national industrialization will create decent work and resolve poverty and bring equality in society but this was not funded under House Bill No. 6215.
12. Rep. Tom S. Villarín said he voted in the affirmative but expressed strong reservations on the 2018 budget because it was an aggressive spending measure and heavy on infrastructure but very light on

social reforms; allocated negligible amounts for agrarian reform, sustainable agriculture, human settlements, and reproductive health but gave lump sum amounts for intelligence funds for EJK measures under the PNP budget and other destructive measures on human rights; and it looked down on human rights by cutting down ₱114 million of the CHR’s budget. He said that even if the budget had a pump-priming effect on the economy, its trickle-down effect on the marginalized and disadvantage sectors will be negligible. He stressed that the budget fell short on principles and values.

13. Rep. Carlos Isagani T. Zarate said he was voting against House Bill No. 6215 because it contradicted the budget message of the President, as this will not deliver a stable, comfortable, and secure life for the people. He pointed out that aside from some budget increases in other agencies, this did not differ from the budgets of past administrations; did not address the major problems of the people; reduced the budget for social services such as health and housing while providing huge subsidy to large local and foreign corporations; and aggravated the “state of impunity.” He said that the budget was geared towards the implementation of the Tax Reform for Acceleration and Inclusion or TRAIN measure which will heavily burden the Filipino people and that there was no real change that the citizens can expect from the 2018 budget proposal.

APPROVAL OF JOURNAL NO. 28

On motion of Rep. Salvador B. Belaro Jr., there being no objection, the Body approved Journal No. 28, dated September 25, 2017.

BUSINESS FOR THE DAY: COMMITTEE REPORT NO. 386 ON HOUSE JOINT RESOLUTION NO. 15

On successive motions of Representative Belaro, there being no objection, the Body considered

on Second Reading House Joint Resolution No. 15, as contained in Committee Report No. 386 and submitted by the Committee on Housing and Urban Development, authorizing the National Housing Authority to award to other qualified beneficiaries the unawarded housing units in the Armed Forces of the Philippines (AFP)/Philippine National Police (PNP)/Bureau of Fire Protection (BFP)/Bureau of Jail Management and Penology (BJMP)/Bureau of Corrections (BuCor) housing projects, awarded housing units that are not yet occupied and whose ownership and possession are surrendered by their respective awardees, and housing units whose respective awards were cancelled by reason of default in the payment of amortization or for any violation of the terms and conditions of the individual loan agreement in accordance with existing laws; dispensed with the reading of the text of the measure without prejudice to its insertion into the Record of the House; adopted the Explanatory Note as the sponsorship remarks on the measures; terminated the period of sponsorship and debate; terminated the period of amendments in the absence of Committee and individual amendments; and approved the same on Second Reading through *viva voce* voting.

OMNIBUS APPROVAL ON SECOND READING OF CERTAIN HOUSE BILLS UNDER THE BUSINESS FOR THURSDAY AND FRIDAY

On an omnibus motion of Rep. Alexandria P. Gonzales, there being no objection, the Body considered on Second Reading the following House Bills calendared under the Business for Thursday and Friday, as contained in various Committee Reports and submitted by the Committees hereunder indicated; dispensed with the reading of the texts thereof without prejudice to their insertion into the Record of the House; adopted the Explanatory Notes as the sponsorship remarks on the measures; terminated the period of sponsorship and debate; terminated the period of amendments in the absence of Committee and individual amendments; and approved the same on Second Reading through *viva voce* voting:

1. House Bill No. 6316, as contained in Committee Report No. 372 and submitted by the Committee on Legislative Franchises, granting Northeastern Broadcasting Services, Inc. a franchise to construct, install, establish, operate and maintain radio and television broadcasting stations in Isabela Province and Region II;

2. House Bill No. 6394, as contained in Committee Report No. 379 and submitted by the Committee on Natural Resources, declaring the Mayon Volcano Natural Park in Albay as a protected area and providing for its management;
3. House Bill No. 3979, as contained in Committee Report No. 385 and submitted by the Committee on Natural Resources, declaring two parcels of lands of the public domain located in Naga City, Cebu as agricultural land open to disposition for agricultural, residential, commercial, industrial or other productive purposes;
4. House Bill No. 6418, as contained in Committee Report No. 387 and submitted by the Committee on Revision of Laws, declaring October 26 of every year a special nonworking holiday in Catanduanes to be known as the "Foundation Day of Catanduanes";
5. House Bill No. 2097, as contained in Committee Report No. 388 and submitted by the Committee on Revision of Laws, declaring December 2 of every year a special nonworking holiday in Pasay City to be known as the "Foundation Day of Pasay City"; and
6. House Bill No. 6426, as contained in Committee Report No. 390 and submitted by the Committee on Natural Resources, declaring as agricultural land certain parcels of land of the public domain situated within Surigao City, Surigao del Norte.

ADOPTION OF CERTAIN HOUSE RESOLUTIONS

On successive motions of Representative Gonzales (A.P.), there being no objection, the Body considered the following House Resolutions; dispensed with the reading of the texts thereof without prejudice to their insertion into the Record of the House; and unanimously adopted the same:

1. House Resolution No. 1292, entitled: "A RESOLUTION CONGRATULATING AND COMMENDING FILIPINO ACTRESS AND CONGRESSWOMAN VILMA SANTOS-RECTO FOR WINNING THE MOST COVERED MOVIE ACTRESS OF THE

YEAR AWARD IN THE 33RD PHILIPPINE MOVIE PRESS CLUB'S STAR AWARDS FOR MOVIES FOR THE FILM 'EVERYTHING ABOUT HER'; and

2. House Resolution No. 1337, entitled: "A RESOLUTION EXPRESSING THE SENSE OF THE HOUSE OF REPRESENTATIVES OF THE PHILIPPINES, TO SUPPORT THE APPEAL OF PRESIDENT RODRIGO ROA DUTERTE TO THE GOVERNMENT OF THE UNITED STATES OF AMERICA FOR THE RETURN OF THE BELLS OF BALANGIGA THAT WERE TAKEN AS TROPHIES OF WAR BY AMERICAN MILITARY TROOPS IN 1901."

MANIFESTATION OF REPRESENTATIVE EVARDONE

As he expressed support for House Resolution No. 1337, Rep. Ben P. Evardone quoted President Duterte's second State of the Nation Address wherein he described the attack made by United States (US) forces in Balangiga, Samar during the Philippine-American War in the 1900s; seizure of the church bells from the town church as war trophies; and eventual display thereof in several American air bases in other countries. He said that the unreturned bells cast doubt on the resolve of modern society to heal the wounds of war. He reiterated the President's appeal for the return of the Balangiga Bells as they are part of the Filipino national heritage and will put closure to a bloodied chapter of Philippine history.

At this point, Representative Sy-Alvarado sought permission to interpellate Representative Evardone.

MANIFESTATION OF REPRESENTATIVE ELAGO

Recognized by the Chair on motion of Representative Gonzales (A.P.), Representative Elago, as the youth convenor of the Lingganay ng Kalayaan or Bells of Freedom Campaign Movement, expressed her advocacy for the return of the Balangiga Bells; the fight for justice against the American war of aggression in the country; and the demand for an apology from the US government for the atrocities they had committed against the Filipino people. She also stressed the need to continuously defend the nation's territory, sovereignty, and dignity.

The Chair thereafter recognized Representative Sy-Alvarado for his manifestation.

MANIFESTATION OF REPRESENTATIVE SY-ALVARADO

Speaking in Filipino, Representative Sy-Alvarado first thanked his colleagues who supported the return to the Philippines of the Balangiga Bells. He then expressed belief that the Philippines won the war against the US in the Philippine-American War; condemned the American soldiers' massacre of the province of Samar; and opined that the return of said bells would finally heal the country's wounds.

(JCADI), firm of the Soriano family of Agusan del Norte, on the 210-hectare agricultural land covered by Tubay Agricultural Processing Center (TAPCEN) located in Doña Rosario, Tubay Town of said province – to the Committee on Agrarian Reform;
4. House Resolution No. 1315, on the plight of agricultural workers under NGPI – Agrarian Reform Beneficiaries Multi-Purpose Cooperative (NGPI-ARB MPC) with the Department of

- Agrarian Reform-approved petition for individual titling of part of the 3,826.24 hectares of agricultural land being leased by Filipinas Palmoil Plantation, Inc. in the towns of San Francisco and Rosario in Agusan del Sur – to the Committee on Agrarian Reform;
5. House Resolution No. 1316, on the impact of the implementation of R.A. No. 8550 or the Philippine Fisheries Code of 1998 and its amendments under R.A. No. 10654 and other government programs and policies on the small fisherfolk sector of the CARAGA Region – to the Committee on Aquaculture and Fisheries Resources;
 6. House Resolution No. 1318, on the deployment by the U.S. Armed Forces of a “Gray Eagle” drone in Mindanao, and calling for its immediate withdrawal from Philippine territory – to the Committee on National Defense and Security;
 7. House Resolution No. 1319, on the deployment of Gray Eagle Unmanned Aircraft Systems (UAS) to Mindanao by U.S. forces and its implication to national security – to the Committee on National Defense and Security;
