SENATE TRANSMITTAL OF HOUSE BILLS

Thereupon, on motion of Representative Mercado, there being no objection, the Chair directed the Secretariat to immediately transmit to the Senate the recently-approved Bills on Third Reading.

THE PRIVILEGE HOUR

The day being a Monday, on motion of Representative Mercado, there being no objection, the Chair declared a Privilege Hour.

ACKNOWLEDGMENT OF GUESTS

At this point, Representatives Mercado/Garin (R.) acknowledged the presence in the Session Hall of guests of Reps. Henry S. Oaminal, Sabiniano S. Canama, Anthony M. Bravo, Ph.D., Rico B. Geron, and Raul V. Del Mar.

Thereafter, on motion of Representative Mercado, the Chair recognized Rep. Arnolfo "Arnie" A. Teves Jr. for his privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE TEVES

Representative Teves spoke about tax evasion. He recalled that he had already asked, during the budget deliberation, how the Bureau of Internal Revenue (BIR) was collecting taxes from several

big companies who had been seemingly under-declaring their incomes; and pointed out that because the government could not collect proper taxes from big companies, it was burdening low-income earners with new or additional taxes. He also said that he had suggested the purchase by the Bureau of Customs (BOC) of x-ray machines for all ports of entry, so as to help it properly collect taxes; pointed out that he had sent letters thereon to President Rodrigo Roa Duterte and the Senators; and explained that a “No x-ray, No entry” policy will help the BOC to meet its targets.

Thereupon, Representative Teves reminded the BIR and the BOC to make sure that they do their work properly and look into private companies and individuals who were avoiding the payment of taxes.

REFERRAL OF REPRESENTATIVE TEVES’ PRIVILEGE SPEECH

On motion of Representative Garin (R.), there being no objection, the Body referred the privilege speech of Representative Teves to the Committee on Rules.

SUSPENSION OF SESSION

The Chair suspended the session at 4:52 p.m., upon motion of Representative Garin (R.).

RESUMPTION OF SESSION

The session resumed at 4:53 p.m.

Thereafter, on motion of Representative Garin (R.), the Chair recognized Rep. Anthony M. Bravo, Ph.D. for his privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE BRAVO (A.)

Representative Bravo’s speech delved on cooperatives in celebration of the National Cooperative Month. He initially spoke of their significance and economic and social relevance; impact on the lives of the people especially the marginalized; socio-economic and livelihood services in their communities; and their contribution to the sustainable and inclusive development goals of the government. He remarked that the House is a party to the successes of the cooperative movement, having supported pertinent policies and legislation such as the Philippine Cooperative Code.

After showing an audiovisual presentation on the growth of a primary cooperative federation, Representative Bravo cited the struggles and challenges faced by cooperatives that hinder them from realizing their objectives. He thus asked for government support for streamlining and harmonizing the regulation of cooperatives; strengthening the Cooperative Development Authority (CDA) or converting it into a regular department; including cooperative education in the education curriculum; developing market linkages for agricultural cooperatives especially in the era of ASEAN economic integration; upholding tax incentives as stipulated in Republic Act (R.A.) No. 9520; and establishing and legalizing a cooperative apex body.

REFERRAL OF REPRESENTATIVE BRAVO’S (A.) PRIVILEGE SPEECH

On motion of Representative Mercado, there being no objection, the body referred the privilege speech of Representative Bravo to the Committee on Rules.

ACKNOWLEDGMENT OF GUESTS

At this point, Representative Mercado acknowledged the presence in the Session Hall of guests of Rep. Tom S. Villarín.

Thereafter, on motion of Representative Mercado, the Chair recognized Rep. Gabriel H. Bordado Jr. for his privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE BORDADO

Representative Bordado said that he stood to speak on behalf of the unemployed, marginalized, those who had been too dependent on private and public assistance for a prolonged period, those who had lost their creativity and dignity as persons, and those who had given up hope in the exercise of their fundamental rights as citizens. He discussed his thoughts about powerlessness as a cause and effect of poverty and the theories of several economists and educators on addressing poverty. He said that he eventually developed insights on the origins and drivers of development; tripartism among the government, private sectors, and civil society; and the Catholic Church’s pronouncement on providing an “option for the poor” even as laws were being crafted to uplift their condition.

Whereupon, Representative Bordado posited that there was a need to overhaul the system of government. He cited President Duterte’s call for a shift to federalism and stressed that the latter should

not only strengthen the autonomy of the regions but should also develop the integrity of the poor and powerless.

REFERRAL OF REPRESENTATIVE BORDADO'S PRIVILEGE SPEECH

On motion of Representative Mercado, there being no objection, the Body referred the privilege speech of Representative Bordado to the Committee on Rules.

PRIVILEGE SPEECH OF REPRESENTATIVE GERON

Recognized by the Chair, on motion of Representative Mercado, Rep. Rico B. Geron said that the theme for the current year's celebration of Cooperative Month was "Cooperatives: Empowering the Poor and the Vulnerable towards Job Creation and Poverty Eradication." Initially, he affirmed that cooperatives have empowered marginalized constituencies to access education, skills training, and employment opportunities. He also mentioned the development of cooperatives through their collaboration with financing institutions such as the Land Bank of the Philippines (LBP) and enumerated those who had received awards under the bank's Gawad Pitak Program.

He however rued the fact that some cooperatives had not been operating successfully and efficiently. He thus proposed more education and training in governance and entrepreneurial skills among cooperatives; the appointment of cooperative development officers in the municipal, city, and provincial levels; the capacitation of the CDA through an increase in its Capital Outlay; and the continuous advocacy for the retention of the tax exemption privilege of cooperatives under R.A. No. 9520.

Representative Geron then emphasized that cooperatives should guard and monitor themselves to keep up with cooperative principles, especially because the private sector and government agencies were supporting the endeavors of their sector. He also cited the fact that the Joint Congressional Oversight Committee on Cooperatives was monitoring the implementation of the Cooperative Code of 2008; and cited hope, self-reliance, and a democratic structure as the bases of successful cooperatives.

REFERRAL OF REPRESENTATIVE GERON'S PRIVILEGE SPEECH

On motion of Representative Garin (R.), there being no objection, the Body referred the privilege speech of Representative Geron to the Committee on Rules.

EXTENSION OF THE PRIVILEGE HOUR

Thereupon, on motion of Representative Garin (R.), there being no objection, the Body extended the Privilege Hour to another one hour and thereafter, the Chair recognized Rep. Sarah Jane I. Elago for her privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE ELAGO

Representative Elago expressed apprehension over various forms of repression, threats, and harassments of campus publications and student councils and organizations. Stressing that student groups play an essential role in advancing the rights and welfare of students, she relayed the details of how the government had been attacking campus press freedom in several schools in the country. She pointed out that such attacks were intensified and supported by the government's other repressive operations such as Oplan Tokhang and martial law in Mindanao.

Representative Elago then urged her colleagues to unite and fight for democratic rights and interests, all for a just and better future for the Filipino masses.

At this point, Deputy Speaker Abu relinquished the Chair to Deputy Speaker Ferdinand L. Hernandez.

REFERRAL OF REPRESENTATIVE ELAGO'S PRIVILEGE SPEECH

Thereupon, on motion of Representative Mercado, there being no objection, the Body referred the privilege speech of Representative Elago to the Committee on Rules.

AMENDMENT TO THE RESULT OF THE ROLL CALL

Pursuant to the amended Provisional Rules of the House, on motion of Representative Mercado, there being no objection, the Body amended the earlier result of the Roll Call to reflect the presence of Rep. Arlene B. Arcillas who was attending the Bicameral Conference Committee on the disagreeing provisions of House Bill No. 6016 and Senate Bill No. 1466.

Thereafter, on motion of Representative Mercado, the Chair next recognized Rep. Emmi A. De Jesus for her privilege speech.

At this juncture, Deputy Speaker Hernandez relinquished the Chair to Deputy Speaker Abu.

PRIVILEGE SPEECH OF REPRESENTATIVE DE JESUS

Representative De Jesus initially said that World Day for Decent Work on October 7 was celebrated in order to register the call for decent work amidst the worsening socioeconomic plight of workers as a result of neoliberal globalization.

Speaking in Filipino, she subsequently lamented the fact that the Duterte Government was insensitive to the real issues and concerns of “wage and salary workers” who compose 70 percent of the labor force. She criticized the issuance of Department of Labor and Employment (DOLE) Order No. 174 which effectively legalized contractualization but which the government had promised to end.

After citing Shoemart, Inc. as a business establishment which continued to implement contractualization aside from not paying its workers for overtime and night differential services, Representative De Jesus also criticized the compressed work-week proposal and the increase in the prices of basic goods and services despite the non-increase in the minimum wage.

Thereupon, questioning the continuation of neoliberal policies by the Duterte Administration, she appealed to Congress to address the longstanding plea of the labor force for the provision of decent work, realistic salary increases, and a national minimum wage; as well as for the recognition of the workers’ right to unionize.

REFERRAL OF REPRESENTATIVE DE JESUS’ PRIVILEGE SPEECH

On motion of Representative Garin (R.), there being no objection, the Body referred the privilege speech of Representative De Jesus to the Committee on Rules.

DESIGNATION OF ADDITIONAL HOUSE CONFEREE ON HOUSE BILL NO. 5670 AND SENATE BILL NO. 1465

On motion of Representative Mercado, there being no objection, the Body designated Rep. Ariel “Ka Ayik” B. Casilao as additional House conferee

to the Bicameral Conference Committee to reconcile the disagreeing provisions of House Bill No. 5670 and Senate Bill No. 1465 on the Free Irrigation Services Act.

CONCURRENCE WITH SENATE AMENDMENT TO HOUSE BILL NO. 4942

With the consent of the Committee on Local Government as well as the author of the measure, on motion of Representative Mercado, there being no objection, the Body concurred with the Senate amendments to House Bill No. 4942, creating Barangay Pudo in Natonin, Mountain Province.

Thereafter, on motion of Representative Garin (R.), the Chair recognized Rep. Tom S. Villarín for his privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE VILLARIN

Speaking in Filipino, Representative Villarín decried the demolition of the houses of informal settlers in Barangays North Bay Boulevard, Navotas and Talayan, San Francisco del Monte, Quezon City. He pointed out that no consultations were made by the Housing and Urban Development Coordinating Council (HUDCC), the National Housing Authority (NHA), and the Commission on Human Rights (CHR) with the stakeholders in order to protect their rights and ensure a ready and decent relocation site for them.

On behalf of the Akbayan Party-List, Representative Villarín thus expressed hope that the House will pass bills that will ensure an on-site, in-city, and near-city relocation program as well as create a Department of Human Settlements and Urban Development. Discussing different and alternative housing systems and programs, he asked the government including the House to listen to informal settler families in order to come up with an affordable and decent housing policy.

REFERRAL OF REPRESENTATIVE VILLARIN’S PRIVILEGE SPEECH

Thereupon, on motion of Representative Garin (R.), there being no objection, the Body referred the privilege speech of Representative Villarín to the Committee on Rules.

REOPENING OF THE PRIVILEGE HOUR

With leave of the House, on successive motions of Representative Garin (R.), there being no objection, the Body reopened the Privilege Hour and the Chair thereafter, recognized Rep. Mohamad Khalid Q. Dimaporo for his privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE DIMAPORO (M.K.)

Representative Dimaporo said that the filing of the Bangsamoro Basic Law or House Bill No. 6475 may mark the end of the Autonomous Region in Muslim Mindanao (ARMM).

Initially, he recalled relevant historical events including the founding of the Moro National Liberation Front (MNLF) in 1972; the creation of the ARMM under the Cory Administration; the amendment of the ARMM Law during the Ramos Administration; and the calling for a new entity called Bangsamoro under the PNoy Administration after peace negotiations with the Moro Islamic Liberation Front (MILF).

He thereafter discussed the current state of the ARMM. He enumerated the latter's various accomplishments and innovative reforms as it had presented during the 2018 Committee budget briefings; and said that the ARMM was a far cry from what it was six years ago when it was declared a failed experiment. He stressed that it was the national government that failed the ARMM, as he appealed for the restoration of billions of funds taken out of the ARMM budget allegedly for the free tertiary tuition program.

In conclusion, he asked the Body to act on the resolutions he filed for (1) an increase in the budgets of line agencies in the ARMM; and (2) an assessment of the administrative relationship between Department of Education's Central Office and ARMM Regional Office. He expressed hope that the House will revisit what caused the ARMM to fail when deliberating the BBL or else the Body might be simply changing a "failed" experiment with another experiment.

REFERRAL OF REPRESENTATIVE DIMAPORO'S (M.K.) PRIVILEGE SPEECH
