PROPOSED AMENDMENTS OF REPRESENTATIVE LAGMAN

Citing an agreement with the Senior Deputy Majority Leader regarding his intent to propose amendments, Representative Lagman moved to insert several provisions subject to style and the situs where the same will be provided for, the first of which was as follows: THE EXPLANATION OF VOTE OF A MEMBER DURING THIRD READING SHALL BE MADE IMMEDIATELY AFTER SUCH MEMBER SHALL CAST HIS OR HER VOTE.

REMARKS OF REPRESENTATIVE DEFENSOR

After asking the Body to go through the proposals one by one, Representative Defensor cited two rules on the explanation of vote, thus: (1) if the Body is conducting nominal voting for the approval of measures on Third Reading, the explanation of vote comes after the announcement of the voting results; and (2) if the Body is conducting nominal voting in response to the request of a Member for nominal voting, which request has been acceded to by one-fifth of the Members of the House, the explanation of vote is not done after the announcement of results.

At this point, Representative Lagman pointed out that his proposed amendment was precisely in consideration of nominal voting during the approval of measures on Third Reading.

Representative Defensor explained the need to facilitate the voting process during the approval of measures on Third Reading and cited the rule that voting should not be interrupted in said situation.

Thereupon, Representative Lagman argued that the explanation of vote does not interrupt the voting process but is a part of it; and pointed out that such has been the rule since the 8th Congress until it was recently abandoned. He explained that Members need to immediately explain their vote because allowing them to do so after the voting results have been announced will be a post-mortem explanation and not an active explanation.

REMARKS OF SPEAKER MACAPAGAL-ARROYO

My fellow Representatives, Christmas is the best time to thank all those who have helped us do our jobs. During the first two-and-a-half years of President Rodrigo Roa Duterte's term, the Executive put in place a set of policies to guide the country's economic and infrastructure development in

the coming years. For its part, the Legislative enacted a set of laws in support of those policies.

During the day of the State of the Nation Address (SONA) last July 2018, I accepted the offer of support of many Representatives who elected me Speaker of the House. It is an honor to be the House Speaker and it is a position that I do not take lightly, and I thank you all for your support and cooperation.

As you have seen, my leadership and management style as Speaker is still similar as when I was President. The key words are hard work; selectively hands-on, especially in shepherding the 2018 SONA bills of President Duterte to passage by the House; strict, but hopefully fair; and open-minded.

Since the Third Regular Session of the 17th Congress' opening in July this year, as of an hour ago, we have already processed about 1,361 bills and approved 492 of those measures. We have approved 492 measures including 95 passed into law, 39 bills ready for the President's signature, 27 with ratified bicameral reports, 25 on Bicameral Conference Committees, 22 approved on Second Reading, plus 38 approved resolutions. We have processed an average of 33 measures per day. Congratulations!

More important for me, shortly after I assume the Speakership, I told you, my colleagues, that my goal is to implement the legislative agenda of President Duterte and you have seen that the legislation of the House has prioritized these past six months the priority bills announced by the President in his 2018 SONA.

My concern is not my legacy as Speaker, my concern is to support President Duterte's legacy in the year that I have as Speaker. And as of yesterday, the House can report with confidence that we have already passed the President's entire legislative agenda as he announced in his 2018 SONA. So you all deserve congratulations and thanks.

Thus, the country already has a good policy framework in place supported by good legislation. There will always be room for making new policy and legislation. And next year, we will be able to attend to your pet bills but on the whole, I think it is

time to pivot from mere policies to implementation. We must harvest the results during the final three-and-a-half years of President Duterte's term. The area of government that is most responsible for this is the Executive.

For the remaining months of the 17th Congress, I ask the House to be prepared to give the implementing departments and agencies the support that they may need to the extent that they make this pivot from policy to action such as by way of House resolutions from us, the elected Representatives of the people, or through the helpful exercise of House oversight functions.
