At this juncture, Representative Gonzales (A.D.) acknowledged the presence in the Session Hall of guests of Reps. Rogelio J. Espina, M.D. and Nancy A. Catamco.

**UNFINISHED BUSINESS:
COMMITTEE REPORT NO. 389
ON HOUSE BILL NO. 6425**

On motion of Representative Gonzales (A.D.), there being no objection, the Body resumed the consideration on Second Reading of House Bill No. 6425, as embodied in Committee Report No. 389 and reported out by the Committees on Transportation, and Appropriations.

Upon direction by the Chair, the Secretary General read the title of the Bill, to wit:

“AN ACT PRESCRIBING AN URGENT, COMPREHENSIVE AND INTEGRATED LAND-BASED TRAFFIC MANAGEMENT POLICY TO EFFECTIVELY ADDRESS THE TRAFFIC CONGESTION CRISIS IN METRO MANILA, METRO-

POLITAN CEBU AND METROPOLITAN DAVAO AND APPROPRIATING FUNDS THEREFOR.”

Representative Gonzales stated that the parliamentary status was that the Bill was in the period of sponsorship and debate; and thereafter, on his motion, the Chair recognized Rep. Cesar V. Sarmiento, Chairperson of the Committee on Transportation, to sponsor the same.

SPONSORSHIP SPEECH OF REPRESENTATIVE SARMIENTO (C.)

Representative Sarmiento initially stated that the 44-section House Bill No. 6425 or proposed Traffic Crisis Act was an urgent, immediate, and comprehensive response to the traffic crisis. In presenting an outline of the Bill's contents, he first examined the current transportation crisis and stressed that it could be managed by a single policy-making and regulatory body with the assistance of existing agencies which enforce traffic laws and promote road safety.

The Sponsor noted that the government is obsessed with grand lengthy infrastructure and transportation projects whose long gestation periods only worsen traffic conditions. He said that there were no proper systems, mechanisms, and processes that can give immediate relief to the traffic-stressed public. He maintained that while there are many factors that contribute to the worsening traffic crisis in major cities, no one is willing to sacrifice because jobs are on the line.

Thereafter, Representative Sarmiento explained how House Bill No. 6425 seeks to solve the traffic crises in Metro Manila, Metropolitan Cebu, and Metropolitan Davao by addressing the following areas: 1) the organizational structure of the transport sector including the role of local government units and a Traffic Chief; 2) negotiated contracts for priority projects; 3) support systems including the harmonization of laws, a traffic management plan, and traffic education; 4) support mechanisms for displaced transport workers; and 5) oversight and transparency. He also explained the duration or the validity of the authority granted to the agencies concerned under the instant measure.

In conclusion, Representative Sarmiento pointed out that emergency power is not needed in solving the traffic problem but only the exercise of Congress' plenary power. He then asked his colleagues to support the passage of House Bill No. 6425.

On Majority Leader Fariñas' motion, there being no objection, the Chair directed the Secretary General to drop the name of Representative Roque (H.) from the Roll of Members of the House of Representatives.
