**UNFINISHED BUSINESS:  
COMMITTEE REPORT NO. 509  
ON HOUSE BILL NO. 6772**

On motion of Representative Roa-Puno, there being no objection, the Body resumed consideration on Second Reading of House Bill No. 6772, as contained in Committee Report No. 509 and reported out by the Committees on Natural Resources, Appropriations, and Ways and Means.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

“AN ACT ENSURING THE PRESERVATION AND MANAGEMENT OF PROTECTED AREAS, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 7586 OTHERWISE KNOWN AS THE NATIONAL INTEGRATED PROTECTED AREAS SYSTEM ACT OF 1992.”

Representative Roa-Puno stated that the parliamentary status of the Bill was that it was in the period of sponsorship and debate; and on her motion, the Chair recognized Rep. Arnel U. Ty, Chairperson of the Committee on Natural Resources, to sponsor the measure and Rep. Jose L. Atienza Jr. to interpellate thereon.

**REMARKS OF REPRESENTATIVE TY**

Representative Ty requested that Rep. Josephine Ramirez-Sato, one of the main authors of the Bill, be recognized to defend the measure.

On motion of Rep. Gerald Anthony “Samsam” V. Gullas Jr., the Chair recognized Representative Ramirez-Sato.

**INTERPELLATION OF  
REPRESENTATIVE ATIENZA**

Representative Atienza stated at the outset that he would like to clarify certain issues to ensure the success of the intent of the measure. He then congratulated the Sponsor and all the Members who co-authored the measure for their initiative.

Representative Atienza subsequently agreed that the measure had long been awaiting action but opined that while the measure is both necessary and good, it must learn from Republic Act (RA) No. 7586 or the National Integrated Protected Areas System (NIPAS) Act of 1992. He also said that while he is grateful that the Sponsor recognized his accomplishments as a former Secretary of the Department of Natural Resources (DENR), he admits that protected areas have not been safeguarded

enough. As he concurred that violations in protected areas should be meted with heavier penalties, he asked whether the measure will really stop the destruction of said areas; who will enforce the new law; and what will be the role of local government units (LGUs).

Representative Ramirez-Sato opined that LGUs are frontliners in the defense of the environment. She said that the DENR is mandated to be the primary government agency responsible for the conservation, management, development, and proper use of the country's environment and natural resources; and that if such responsibility is transferred to the LGUs, such is a usurpation of the mandate of the DENR. She however clarified that the Bill provides for the participation of LGUs through their representation in the Protected Area Management Board (PAMB) whose duties and functions she discussed.

Representative Atienza reminded the Sponsor that the principle of local autonomy as enshrined in the Constitution provides that all LGUs are given all the power, more than any government agency, to plan and push for the development of their areas as well as protect their territories. He also said that LGUs should be accountable for the protected areas within their jurisdiction.

To Representative Atienza's succeeding concern that the DENR and LGUs, particularly the mayors, should be made equally responsible for protecting the different bodies of water in the country, the Sponsor said that 1) the powers and role of the DENR in implementing the proposed law cannot be usurped by the LGUs and that the latter would be given complementary functions; 2) the proposed management plan would be participated in and strictly followed by the DENR, LGUs and nongovernment organizations (NGOs); 3) a joint congressional oversight committee would ensure the strict implementation of and compliance with the law; 4) the LGUs would play a critical but not primary role in the implementation of the measure which is the mandate of the DENR; and 5) violators of prohibited acts, whether public officials or private individuals, would be fined or imprisoned from one year to six years, or from six years to 12 years, depending on the crimes committed.

Representative Ramirez-Sato also assured Representative Atienza that at the appropriate time, the sponsoring Committee would be willing to accept an amendment making local officials who have failed to observe the law, administratively and/or criminally liable.

## ACKNOWLEDGMENT OF GUESTS

At this point, Representative Roa-Puno acknowledged the presence in the Session Hall of guests of Rep. Alfredo "Albee" B. Benitez.

Thereafter, on motion of Representative Roa-Puno, the Chair recognized Rep. Carlos Isagani T. Zarate for his interpellation.

## INTERPELLATION OF REPRESENTATIVE ZARATE

Speaking in Filipino, Representative Zarate pointed out the failure of RA No. 7586 in ensuring the preservation of protected areas and in particularly protecting the interest of indigenous peoples (IPs) in terms of land use and commercialization of protected areas, as well as their displacement and symbiotic relationship to their ancestral domain. He asked about the ongoing displacement of the IPs and how together with the upland settlers, they would still be displaced because of the proposed law; the slow issuance of Certificates of Ancestral Domain Title (CADTs) especially for ancestral lands; the number of protected areas that have already been declared by Congress; and the IPs' practice of poaching, which is prohibited under the Bill.

As she clarified that the issuance of CADTs is covered by a different law, Representative Ramirez-Sato said that the measure respects and promotes areas for IPs and indigenous cultural communities (ICCs) and their pre-existing rights to ancestral lands, and seeks to declare 107 protected areas in 53 provinces covering some three million hectares of land. She added that to address the practice of poaching, IPs would be given alternative means of livelihood.

The two Members then exchanged views about the extent of the PAMB's authority to permit or prohibit lumads and IPs from hunting and engaging in wildlife-related activities and the severity of the punishment and penalties for the same; the effectiveness of the NIPAS Act in protecting the environment; and the necessity of expanding the coverage of protected areas.

Whereupon, Representative Zarate said that if the measure allows the establishment of non-renewable energy projects inside the protected areas, it will defeat its purpose. He also expressed concern that protected areas may soon be under external and foreign control and exploration if ever the proposal to amend or revise the present Constitution would push through.

## **ACKNOWLEDGMENT OF GUESTS**

At this point, Representative Roa-Puno acknowledged the presence in the Session Hall of guests of Reps. Gloria Macapagal-Arroyo.

## **INTERPELLATION OF REPRESENTATIVE VILLARIN**

Next recognized by the Chair upon Representative Roa-Puno's motion, Representative Villarín initially asked whether the measure intends to extend protection to marine areas such as reefs and marine breeding grounds. Representative Ramirez-Sato asked her colleague to submit to the Committee his proposed amendment.

The two Members subsequently discussed Representative Villarín's apprehension about the constitutionality of including Senators and Members of the House in an executive body, considering the principle of separation of powers between the Legislative and the Executive branches of government; and his proposal to make IP representation in PAMB as mandatory.

## **TERMINATION OF THE PERIOD OF SPONSORSHIP AND DEBATE**

There being no other interpellations, on motion of Representative Gullas, there being no objection, the Body terminated the period of sponsorship and debate.

## **SUSPENSION OF CONSIDERATION OF HOUSE BILL NO. 6772**

On motion of Representative Gullas, there being no objection, the Body suspended the consideration on Second Reading of House Bill No. 6772.

## **BUSINESS FOR THE DAY: COMMITTEE REPORT NO. 564 ON HOUSE BILL NO. 6923**

On motion of Representative Gullas, there being no objection, the Body considered on Second Reading House Bill No. 6923 as embodied in Committee Report No. 564 and reported out by the Committees on Government Enterprises and Privatization, and Appropriations.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

“AN ACT STRENGTHENING THE PHILIPPINE CROP INSURANCE CORPORATION (PCIC), REPEALING FOR THE PURPOSE PRESIDENTIAL DECREE

NO. 1467, ENTITLED 'CREATING THE “PHILIPPINE CROP INSURANCE CORPORATION” PRESCRIBING ITS POWERS AND ACTIVITIES, PROVIDING FOR ITS CAPITALIZATION AND FOR THE REQUIRED GOVERNMENT PREMIUM SUBSIDY, AND FOR OTHER PURPOSES', AS AMENDED BY PRESIDENTIAL DECREE NO. 1733 AND REPUBLIC ACT NO. 8175.”

As copies of the Bill had been distributed to the Members, on motion of Representative Gullas, there being no objection, the Body dispensed with the reading of the text of the measure without prejudice to its insertion into the Record of the House.

On motion of Representative Gullas, the Chair recognized Rep. Jesus Nonato Sacdalan, Chairperson of the Committee on Government Enterprises and Privatization, to deliver his sponsorship speech.

## **SPONSORSHIP SPEECH OF REPRESENTATIVE SACDALAN**

Representative Sacdalan enumerated the objectives of the Bill, as follows: to expand the types of agricultural crops that can be insured by the Philippine Crop Insurance Corporation (PCIC), to include life and accident insurance for farmers and fisherfolk and their dependents; to strengthen the financial and organizational capacity of the PCIC; and to encourage private insurance companies to offer crop insurance which will include all other crops being introduced in the country. He expressed hope that the Body will approve the measure.

On motion of Representative Gullas, the Chair recognized Rep. Anthony M. Bravo, Ph.D. to deliver his sponsorship speech.

## **SPONSORSHIP SPEECH OF REPRESENTATIVE BRAVO (A.)**

Representative Bravo stated that the Bill is not only favorable to the Filipino farmers but to the country as a whole considering that crop insurance is a major component in ensuring food security. He stressed the impact of climate change on the agriculture and fishery sectors and the effect of the typhoons, floods, and drought to the production of rice, corn, and high-value crops including vegetables and fruit trees. He said that by strengthening the PCIC, the measure also authorizes it to extend life and accident insurance coverage for farmers and fisherfolk; ensure properties and facilities of the government used in agri-fishery-forestry projects, offer Weather Index Based Insurance; and encourage private commercial banks to sell crop insurance.

He appealed to the Members to pass the measure with dispatch to give farmers a safety net that they deserve, thus ensuring food security and an empowered agricultural sector.

#### **TERMINATION OF THE PERIOD OF SPONSORSHIP AND DEBATE**

There being no interpellations, on motion of Representative Roa-Puno, there being no objection, the Body terminated the period of sponsorship and debate.

The Body then proceeded to the period of amendments.

#### **TERMINATION OF THE PERIOD OF AMENDMENTS**

There being no Committee or individual amendments, on motion of Representative Roa-Puno, there being no objection, the Body terminated the period of amendments.

#### **APPROVAL ON SECOND READING OF HOUSE BILL NO. 6923**

On motion of Representative Roa-Puno, there being no objection, the Body approved on Second Reading House Bill No. 6923 through *viva voce* voting.

#### **BUSINESS FOR THE DAY: COMMITTEE REPORT NO. 532 ON HOUSE BILL NO. 6775**

On motion of Representative Roa-Puno, there being no objection, the Body considered on Second Reading House Bill No. 6775 as embodied in Committee Report No. 532 and reported out by the Committees on Government Reorganization, Housing and Urban Development, and Appropriations.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

“AN ACT CREATING THE DEPARTMENT OF HUMAN SETTLEMENTS AND URBAN DEVELOPMENT, DEFINING ITS MANDATE, POWERS AND FUNCTIONS, AND APPROPRIATING FUNDS THEREFOR.”

As copies of the Bill had been distributed to the Members, on motion of Representative Roa-Puno, there being no objection, the Body dispensed with the reading of the text of the measure without prejudice to its insertion into the Record of the House.

On motion of Representative Roa-Puno, the Chair recognized Rep. Xavier Jesus D. Romualdo to deliver his sponsorship speech.

#### **SPONSORSHIP SPEECH OF REPRESENTATIVE ROMUALDO**

Representative Romualdo stated that the instant Bill, which seeks to create a separate Department of Housing, has been included in the priorities of the Legislative-Executive Development Advisory Council (LEDAC). He stressed that the government must be able to face and address the issues and challenges of rapid urbanization, increasing urban poverty, and worsening urban environment. He pointed out that there was no official policy or specific agency of government tasked to resolve the housing problem considering that the number of informal settlers was heavily increasing and further complicating the housing problem.

As he rued the fact that some informal settlers have forcibly occupied housing resettlement units out of extreme desire and necessity to have their own homes, Representative Romualdo stressed the need to establish an integrated and comprehensive housing planning agency through House Bill No. 6775. As he cited several key housing and shelter agencies with their own governing bodies, responsibilities, personnel, systems, and procedures, he explained that the proposed new government entity will provide the necessary focus, impetus, and adequate funding to address the needs and pressing concerns of the housing sector.

Representative Romualdo then concluded that Congress must leave as its legacy, a program that would start hastening the process not only of eradicating or minimizing urban blight but also of helping their poor countrymen live decent and fruitful lives.

Thereafter, on motion of Representative Gullas, the Chair recognized Rep. Alfredo “Albee” B. Benitez, Chairperson of the Committee on Housing and Urban Development, for his sponsorship speech.

#### **SPONSORSHIP SPEECH OF REPRESENTATIVE BENITEZ**

Representative Benitez initially pointed out that the Committee on Housing and Urban Development of the House and the Senate recently sponsored a national summit on housing and urban development where various stakeholders and relevant agencies and sectors participated. The main recommendation thereof, he said, was the creation of a Department of Human Settlements and Urban Development.

After tracing the challenges faced by bills filed on the same subject matter since the Eighth Congress, Representative Benitez opined that House Bill No. 6775 is the key to the country's shelter quandary. He said it was time not only to provide housing but also to establish and nurture human settlements and manage urban development seriously by reengineering the puny housing coordinating body and elevating it into a full-fledged cabinet-ranked agency as has been done in other countries. He stressed that the proposed department will not only be concerned with providing housing but also with building rural and urban communities; and will deal not only with the physical element of housing but also with various basic community services.

Thereupon, Representative Benitez stressed that the long overdue measure shall reaffirm and reassert the House' political will to introduce change for the better and to serve the greater good.
