**BUSINESS FOR THE DAY:
COMMITTEE REPORT NO. 477
ON HOUSE BILL NO. 6649**

On successive motions of Rep. Alexandria P. Gonzales, there being no objection, the Body considered on Second Reading House Bill No. 6649, as contained in Committee Report No. 477 and submitted by the Committee on Overseas Workers Affairs, strengthening further the pre-departure orientation program for overseas Filipino workers (OFWs) to include financial and entrepreneurial education, amending for the purpose Republic Act No. 8042, as amended, otherwise known as the Migrant Workers and Overseas Filipinos Act of 1995; dispensed with the reading of the text of the Bill without prejudice to its insertion into the Record of the House; as concurred by Rep. Jesulito A. Manalo, Chairperson of the sponsoring Committee, adopted the Explanatory Note of the Bill as the sponsorship remarks on the measure; terminated the period of sponsorship and debate; terminated the period of amendments in the absence of Committee and individual amendments; and approved House Bill No. 6649 on Second Reading through *viva voce* voting.

**BUSINESS FOR THE DAY:
COMMITTEE REPORT NO. 503
ON HOUSE BILL NO. 6306**

On successive motions of Representative Gonzales (A.P.), there being no objection, the Body considered on Second Reading House Bill No. 6306, as contained in Committee Report No. 503 and submitted by the Committee on Basic Education and Culture, recognizing the British School Manila as an educational institution of international character, granting certain prerogatives conducive to its development as such; dispensed with the reading of the text of the Bill without prejudice to its insertion into the Record of the House; adopted the Explanatory Note of the Bill as the sponsorship remarks on the measure, on motion of Rep. Ramon “Red” H. Durano VI, Chairperson of the sponsoring Committee; terminated the period of sponsorship and debate; and thereafter, proceeded to the period of amendments.

COMMITTEE AMENDMENTS

As proposed by Representative Gonzales (A.P.), there being no objection, the Body approved the

Committee amendments on page 3 and in the title of House Bill No. 3606; and thereafter, proceeded to the period of individual amendments.

AMENDMENT OF REPRESENTATIVE SALO

As proposed by Rep. Ron T. Salo, and accepted by the Sponsor, there being no objection, the Body approved the former's amendments in Section 4 of the Bill.

BUSINESS FOR THE DAY: COMMITTEE REPORT NO. 503 ON HOUSE BILL NO. 6306 (Continuation)

On further successive motions of Representative Gonzales (A. P.), there being no objection, the Body terminated the period of amendments; and approved on Second Reading House Bill No. 6306, as amended, through *viva voce* voting.

BUSINESS FOR THE DAY: COMMITTEE REPORT NO. 490 ON HOUSE BILL NO. 6710

On successive motions of Representative Gonzales (A. P.), there being no objection, the Body considered on Second Reading House Bill No. 6710, as contained in Committee Report No. 490 and submitted by the Committee on Banks and Financial Intermediaries, providing for additional prohibitions to and increasing penalties for violations of Republic Act No. 8484, otherwise known as the "Access Devices Regulation Act of 1998"; dispensed with the reading of the text of the Bill without prejudice to its insertion into the Record of the House; approved to insert the sponsorship speech of Rep. Ben P. Evardone, Chairperson of the sponsoring Committee, into the Record of the House; terminated the period of sponsorship and debate; and thereafter, in the absence of Committee amendments, proceeded to the period of individual amendments.

AMENDMENTS OF REPRESENTATIVE GARCIA (J. E.)

As proposed by Rep. Jose Enrique "Joet" S. Garcia III, and accepted by the Sponsor, there being no objection, the Body approved the former's amendments on page 5 of House Bill No. 6710.

BUSINESS FOR THE DAY: COMMITTEE REPORT NO. 490 ON HOUSE BILL NO. 6710 (Continuation)

Thereupon, on successive motions of Representative Gonzales (A.P.), there being no objection, the Body terminated the period of amendments; and approved on Second Reading House Bill No. 6710, as amended, through *viva voce* voting.

BUSINESS FOR THE DAY: COMMITTEE REPORT NO. 572 ON HOUSE BILL NO. 6973

Thereupon, on motion of Representative Gonzales (A.P.), there being no objection, the Body considered on Second Reading House Bill No. 6973, as embodied in Committee Report No. 572 and reported out by the Committee on Metro Manila Development.

Upon the direction of the Chair, the Secretary General read the title of the Bill, to wit:

“AN ACT ENHANCING THE EFFECTIVENESS OF THE METROPOLITAN MANILA COUNCIL IN FORMULATING POLICIES, RULES, REGULATIONS, AND IN ENACTING ORDINANCES FOR METRO MANILA, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 7924, ENTITLED, 'AN ACT CREATING THE METROPOLITAN MANILA DEVELOPMENT AUTHORITY, DEFINING ITS POWERS AND FUNCTIONS, PROVIDING FUNDS THEREFOR AND FOR OTHER PURPOSES'.”

As copies of the Bill had been distributed to the Members, on successive motions of Representative Gonzales, there being no objection, the Body dispensed with the reading of the text of the measure without prejudice to its insertion into the Record of the House. The Chair then recognized Rep. Winston "Winnie" Castelo, Chairperson of the Committee on Metro Manila Development, to sponsor the Bill.

SPONSORSHIP REMARKS OF REPRESENTATIVE CASTELO

On motion of Representative Castelo, there being no objection, the Body adopted the Explanatory Note as the sponsorship remarks on the measure.

On further motion of Representative Gonzales, the Chair recognized Rep. Jose L. Atienza Jr. for his interpellation.

INTERPELLATION OF REPRESENTATIVE ATIENZA

Representatives Atienza and Castelo initially discussed the history of the Metropolitan Manila Commission that was transformed into the Metropolitan Manila Authority which, in turn, eventually became the Metropolitan Manila Development Authority (MMDA). The former then discussed with Rep. Bayani F. Fernando, whom the Chair recognized to continue sponsoring the measure, the implementation and effectivity of the development plan for Metro Manila that the MMDA prepared and approved.

Whereupon, Representative Atienza opined that the MMDA was deviating from the Constitution as he pointed out that the latter could not make ordinances because this is a function of local governments. For his part, Representative Fernando maintained that the Metro Manila Commission (MMC) can make ordinances but restricted to the specific mandates of the MMDA.

Even as he supported the passage of a law that would provide for an effective regional government in Metro Manila, Representative Atienza subsequently stressed that such should be in accordance with the Constitution. He adverted to a Supreme Court decision cautioning the MMDA to slow down on its regulatory powers, it being a special body and development planner only and not a local government unit (LGU) and thus should not be given power over and above those who were directly elected by the people. He criticized the inconsistencies of the proposed measure in terms of complying with the constitutional mandate to give power to LGUs but at the same time violating it by inserting provisions authorizing them to collect fees and impose taxes.

Representative Fernando clarified that the intent of the Bill is actually to reduce the power of the MMC by submitting its resolutions and ordinances to the LGUs for their approval or adoption. Representative Castelo, to whom he yielded the floor to sponsor the Bill, also clarified that the powers of the LGUs as embodied in the Constitution will be considered first and foremost.

Representatives Atienza and Castelo then discussed the effectiveness of the "no-smoking ban" policy of the present Administration and the collaboration between the LGUs and the MMDA to solve the traffic problem.

Thereafter, Representative Castelo maintained that the instant measure would empower the Metro Manila mayors to put up and implement a unified,

holistic, and comprehensive traffic code for all of the streets in Metro Manila. However, Representative Atienza expressed disappointment and frustration about the non-inclusion in the Bill of peace and order, flood, and garbage issues; the poor performance of MMDA personnel; the lack of a centralized traffic management system and traffic light system; and the chaotic bus terminal situation.

Representative Atienza then proposed that the Bill be reviewed first before being acted on and suggested the election of a governor for Metro Manila once again as he commended Rep. Imelda R. Marcos's performance as former MMC Chairperson. For his part, Representative Fernando assured Representative Atienza that he would be given a copy of the development plan that he used during his tenure in the MMDA and stressed that the instant bill will resolve the problems of Metro Manila.

SUSPENSION OF SESSION

The session was suspended at 5:40 p.m., upon motion of Representative Gonzales (A.P.).

RESUMPTION OF SESSION

The session resumed at 5:41 p.m.

SUSPENSION OF CONSIDERATION ON SECOND READING OF HOUSE BILL NO. 6973

Thereupon, on motion of Representative Gonzales (A.P.), there being no objection, the Body suspended the consideration on Second Reading of House Bill No. 6973.

UNFINISHED BUSINESS: COMMITTEE REPORT NO. 532 ON HOUSE BILL NO. 6775

On motion of Representative Gonzales (A.P.), there being no objection, the Body resumed consideration on Second Reading of House Bill No. 6775, as contained in Committee Report No. 532 and reported out by the Committees on Government Reorganization, Housing and Urban Development, and Appropriations.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

“AN ACT CREATING THE DEPARTMENT OF HUMAN SETTLEMENTS AND URBAN DEVELOPMENT, DEFINING ITS MANDATE, POWERS AND FUNCTIONS, AND APPROPRIATING FUNDS THEREFOR.”

Representative Gonzales stated that the parliamentary status of the Bill was that it was in the period of sponsorship and debate; and upon her motion, the Chair thereafter recognized Representative Salo, one of the authors of the Bill, to defend the measure and Representative Atienza to interpellate thereon.

INTERPELLATION OF REPRESENTATIVE ATIENZA

Representative Atienza asked what would be the benefit of the proposed new layer of bureaucracy that would control many functions, especially housing, that are already entrusted to LGUs. He also asked whether House Bill No. 6775 would be helpful in implementing the Urban Development and Housing Act (UDHA) that was passed two decades ago.

Representative Salo opined that the proposed Bill does not create a new layer of bureaucracy; establishes an efficient, effective, comprehensive, and integrated national local housing and urban development program; rationalizes, integrates, and coordinates the functions and powers of different housing agencies especially the Housing and Urban Development Coordinating Council (HUDCC) and Housing and Land Use Regulatory Board (HLURB).

Representative Atienza remarked that the Sponsor might want to create a Department of Housing disguised as a Department of Human Settlements and Urban Development (DHSUD). He stressed that the current policy of decentralization is better than centralization because it respects local autonomy; and the matter of housing for the poor should be left to the LGUs which are in the best position to address the same.

At this point, Representative Atienza objected to the creation of the DHSUD as he stressed that the UDHA had already been passed but had yet to be implemented; public funds should instead be allocated for socialized housing; the LGUs, which had the primary responsibility to provide housing, were more sensitive to the problems of the poor; and the instant Bill will create another layer in the bureaucracy.

While he said that he respects Representative Atienza's opinion, Representative Salo emphasized that the proposed DHSUD aims to ensure a comprehensive and integrated housing program.

On motion of Representative Gonzales (A.P.), the Chair recognized Rep. Arlene D. Brosas for her interpellation.

INTERPELLATION OF REPRESENTATIVE BROSAS

Speaking in Filipino, Representative Brosas discussed with Representative Salo the mandate of the proposed DHSUD to 1) address the need for a mass housing program; 2) identify lands for human settlement as well as urban and rural development; 3) ensure the efficient performance of existing government housing agencies; 4) merge the HUDCC and HLURB to become the proposed department's core office; and 5) oversee the different housing agencies.

On the impact of such streamlining, Representative Salo assured his colleague that only the operations of said offices will be affected; and explained that existing employees would have the option to continue working with the government while coterminous employees could stay in the service until the tenure of their bosses will have ended.

He added that the security of tenure of permanent employees would be recognized and that coterminous employees would have more opportunities to apply in the proposed agency as there would be more plantilla positions. He said that the concerns of Representative Brosas would be addressed once the measure is approved.

Thereupon, both Members discussed the parameters of the public-private partnership agreement between the DHSUD and the private sector. Representative Brosas raised her concern on its effect on the low-cost housing program of the government; the powers and functions of the DHSUD in relation to policy development, coordination, monitoring and evaluation of the housing projects, and the implementation of the UDHA; and the effect of the appointment of private sector representatives to the proposed Human Settlements Adjudication Commission (HSAC). Representative Salo stated that the Committee would gladly accept perfecting amendments from his colleague.

Representatives Brosas and Salo then discussed the composition of the commissioners in the HSAC and the advantages of them coming from different sectors and having different points of view and perspectives. Representative Brosas aired her apprehension that the interest of the poor will not be promoted and will be prejudiced by profit-hungry contractors or developers.

On motion of Rep. Benhur B. Lopez Jr., the Chair recognized Rep. Ariel "Ka Ayik" B. Casilao for his interpellation.

INTERPELLATION OF REPRESENTATIVE CASILAO

Representatives Casilao and Salo discussed the backlog and targets in the government's housing program and the increasing number of informal settlers as well as rural poor living in urbanized cities; and how the measure would address these problems. The latter stated that the Bill is not a cure-all but only a part of the many programs and policies that will ensure an efficient, effective, and affordable housing program. The former asked for an assurance that the proposed DHSUD will abide with existing laws and will be able to address the issue of unoccupied housing projects; and said that the Gabriela Women's Party-List and Makabayan Bloc were working on a bill to repeal the defective provisions of the UDHA.

Turning to other matters, Representative Casilao agreed that the measure would facilitate and ensure efficient processes in the housing sector but expressed apprehension that this might also mean the fast-tracking of violent demolition and relocation operations involving urban poor residents. He also questioned the Bill's intent of providing for a housing program that was government-directed and yet market-driven; as well as its lack of provisions for addressing livelihood and employment problems which were persistent problems in relocation sites. He likewise asked about the possible displacement of employees in several housing agencies as a result of the passage of the measure.

In ending his interpellation, he stressed that the problems in the housing sector lie beneath the system or structure and the government should formulate an efficient and effective urban planning and a genuine agrarian reform program to be able to address the same.

On motion of Representative Lopez (B.), the Chair recognized Rep. Emmi A. De Jesus for her manifestation.

MANIFESTATION OF REPRESENTATIVE DE JESUS

Representative De Jesus first acknowledged the presence in the Session Hall of stakeholders of the proposed DHSUD and then asserted that the proposed reorganization of housing agencies and employees will not address the housing problem. She also expressed concern about the policy framework of the Bill which involved ongoing housing programs that did not really serve the interest of the poor and were dominated by businessmen; as well as the threats it posed to the preservation of lands

necessary for food security and the Build-Build-Build program of the Duterte Administration.

Subsequently, Representative De Jesus suggested that dialogues with different stakeholders continue to be held, in order to come up with suggestions and possible amendments to the proposed measure.

TERMINATION OF THE PERIOD OF SPONSORSHIP AND DEBATE

There being no other Member who wished to interpellate the Sponsor, on motion of Representative Lopez (B.), there being no objection, the Body terminated the period of sponsorship and debate.

SUSPENSION OF CONSIDERATION ON SECOND READING OF HOUSE BILL NO. 6775

Thereupon, on motion of Representative Gonzales (A.P.), there being no objection, the Body suspended consideration on Second Reading of House Bill No. 6775.

ADOPTION OF HOUSE RESOLUTION NO. 1614

On successive motions of Representative Gonzales (A.P.), there being no objection, the Body considered House Resolution No. 1614, entitled: "RESOLUTION EXPRESSING THE PROFOUND CONDOLENCES OF THE HOUSE OF REPRESENTATIVES TO THE FAMILY OF ENGINEER OSCAR R. SARMIENTO, FATHER OF EDGAR MARY S. SARMIENTO, REPRESENTATIVE OF THE FIRST DISTRICT OF SAMAR, AND MEL SENEN S. SARMIENTO, FORMER MEMBER OF THE HOUSE OF REPRESENTATIVES AND FORMER DILG SECRETARY"; dispensed with the reading of the text thereof without prejudice to its insertion into the Record of the House; and unanimously adopted the same.

ADDITIONAL COAUTHORS

On motion of Rep. Victoria Isabel G. Noel, there being no objection, the Body approved to include as additional coauthors of House Bill No. 6306, the names of Members contained in the list to be submitted by the Committee on Rules.

CHANGE OF REFERRAL OF CERTAIN MEASURES

On successive motions of Representative Noel, there being no objection, the Body approved the change of referral of the following measures:

1. House Bill No. 4108 – from the Committees on Basic Education and Culture, and Higher and Technical Education to the Committees on Higher and Technical Education, and Basic Education and Culture;
2. House Bill No. 5752 – from the Committee on Natural Resources to the Committee on Transportation; and
3. House Bill No. 6761 – from the Committee on Appropriations to the Committee on Revision of Laws.
