On motion of Rep. Bondoc, the Chair suspended the session at 4:12 p.m.

RESUMPTION OF SESSION

The session resumed at 4:15 p.m.

MANIFESTATION OF REP. ATIENZA

On motion of Rep. Bondoc, the Chair recognized Rep. Jose L. Atienza Jr. who manifested his appreciation for House Resolution No. 696 which the Body had just adopted to commend award-winning Filipino director Lav Diaz. He underscored that it was the Body's way of recognizing outstanding members of the local film industry and providing incentives to Filipino artists and talents who had competed and won in the world competition of film making which used to be dominated by Filipinos. He then thanked the Members who supported the Resolution and expressed hope that they will also support the pending measures providing various incentives such as a tax break, to the film industry so it may become a pillar of the national economy.

Rep. Victoria Isabel G. Noel noted Rep. Atienza's manifestation.

On motion of Rep. Noel, the Chair suspended the session at 4:21 p.m.

RESUMPTION OF SESSION

The session resumed at 4:23 p.m.

ACKNOWLEDGMENT OF GUESTS

Upon resumption of session, Rep. Noel acknowledged the presence in the Session Hall of guests of Reps. Jose Enrique “Joet” S. Garcia III and Mark O. Go.

SUSPENSION OF SESSION

The Chair suspended the session at 4:25 p.m. upon Rep. Noel's motion.

RESUMPTION OF SESSION

The session resumed at 4:25 p.m.

On motion of Rep. Noel, the Chair recognized Rep. H. Harry L. Roque Jr. on a question of personal and collective privilege.

QUESTION OF PRIVILEGE OF REP. ROQUE (H.)

Rep. Roque rose to decry and condemn the news that appeared that day in the Philippine tri-media alleging that he had ceased to be a Member of the House of Representatives. He said that under the Constitution, jurisprudence and existing laws, only Congress can suspend or remove any Member with the exception being under the Ombudsman Law where Congress itself gave the Ombudsman the power to preventively suspend public officials, including Members of Congress, should they be impeached before the Sandiganbayan, for a fixed period of 90 days. He stressed that for as long as a Member of the House had been proclaimed by the Commission on Elections (Comelec), taken his oath and had discharged the functions of his office, only Congress can remove any sitting Member thereof.

Rep. Roque said that until that moment, he had not received any notice from his Party-List Kabayan that there would be such a meeting where the agenda purportedly was his expulsion—he being the first nominee and the face of the party-list that garnered 860,000 votes and placed sixth out of the 115 party-list groups which ran in the 2016 party-list election. He underscored that he should have at least been given the courtesy of being heard before he was allegedly and purportedly expelled from his party-list by what he called a bogus Board of Trustees representing Kabayan.

Thereafter, Rep. Roque cited the purported grounds for his expulsion, as follows: 1) his alleged scandalous conduct during the congressional hearing on the Muntinlupa drug trade involving witness Ronnie Dayan; 2) his purported opposition to the confirmation of Health Secretary Dr. Pauly Jean B. Rosell-Ubial; and 3) his questioning of the lump sum appropriations of the Department of Public Works and Highways (DPWH) during last year's deliberations on the 2017 national budget.

Rep. Roque disagreed on the bogus board's claim that matters brought or comments made on the floor by a Congressman should be approved first by the party-list. If this were so, he said, members of a party-list can just be expelled if a bogus board deems it necessary.

He thereafter thanked the Majority Leader and the Minority Leader for clarifying that he is still a Member of the 17th Congress. He stressed that he has no intention of picking up a fight with the usurpers in his Kabayan Party-List, but underscored the need to protect the mandate given to him by the people, and for which reason he has filed the appropriate legal remedies. He added that only his colleagues in Congress have the power to remove him from office, and expressed his gratitude to them and the House leadership for their support. Finally, he asked the media to give equal prominence to the clarificatory statement given by the Majority Leader.

Thereafter, the Chair recognized Rep. Atienza for his interpellation.

INTERPELLATION OF REP. ATIENZA

Rep. Atienza discussed with Rep. Roque (H.) the contribution to Kabayan Party-List's garnering of two party-list seats in Congress of its support for former Vice-President Jejomar Binay in the last presidential elections; the governance platform that he stood for; and his performance as a Congressman in order to fulfill the campaign promises of Kabayan Party-List to support and enhance the government's health, housing, and livelihood programs. They also delved into Rep. Roque's exclusion by a small group of people within Kabayan and not through the conduct of a national convention or general assembly; the importance of having the Comelec decide on the case as it will render a fair decision thereon; the newspaper accounts that were inclined to make it appear that Rep. Roque was ousted from his position as Representative of Kabayan Party-List; and the lack of notification from the House leadership about said removal. They both agreed to the fact that Rep. Roque's speech on the floor was enough proof that he was still a Member of the 17th Congress.

Thereafter, Rep. Atienza stressed that it was misleading and deceitful to brand Rep. Roque as an ousted Member of the 17th Congress, and noted his active role as a House fiscalizer on issues like the New Bilibid Prison scandal involving Senator Leila De Lima, and the distribution of condoms to students by the Department of Health. Finally, he expressed support to Rep. Roque's continuing struggle for his seat in Congress, and attested to his being an effective member of the Minority.

REMARKS OF THE CHAIR

At this point, the Chair asked Rep. Roque (H.) to confine the topic of his speech to his ouster from the Kabayan Party-List and not divert to any other topic.

REMARKS OF REP. ROQUE (H.)

Rep. Roque submitted thereto, but stressed that there was a link between his alleged expulsion and his opposition to Dr. Ubial's confirmation as Health Secretary. He relayed the information that the Secretary has been assuring everyone that her appointment would be confirmed because he would be removed as a Member of the House. He stressed that he would remain a Member of the House and continue his opposition to said confirmation with even more zeal.

The Chair thereafter recognized Rep. Gil "Kabarangay" P. Acosta to interpellate Rep. Roque.

INTERPELLATION OF REP. ACOSTA

Rep. Acosta first stated that Rep. Roque's (H.) Kabayan Party-List garnered almost the highest number of votes among the party-list candidates in the Province of Palawan, including his district in Puerto Princesa City. He thereafter sought clarification on the deliberations conducted by the Committee on Health on the measure establishing a medical center in the province, which he and the two other Representatives from Palawan had filed.

Rep. Roque explained that Kabayan did not give him a copy of the materials sent to the offices of his colleagues. However, he refuted the allegation that he was objecting to Secretary Ubial's confirmation because she did not accede to his request for the provision of a hospital in Palawan. This, as he clarified that he did not ask for one. He said that he asked for hospital equipment that the Secretary assured would in the meantime be funded through PhilHealth, but which request he found out from an official of the Philippine Amusement and Gaming Corporation was not funded.

Rep. Acosta recalled how Rep. Roque stood firm in fighting for the rightful share of his province to the Malampaya Fund, and assured that his people will continue to support him and his advocacies.

REFERRAL OF REP. ROQUE'S (H.) SPEECH

On motion of Rep. Noel, there being no objection, the Body referred Rep. Roque's speech and the interpellations thereon to the Committee on Rules.

OMNIBUS APPROVAL ON SECOND READING OF BILLS UNDER THE BUSINESS FOR THURSDAY AND FRIDAY

On an omnibus motion of Rep.
