With 219 Members responding to the Call, the Chair declared the presence of a quorum. (See also Appendix 1)

MANIFESTATION OF REP. ATIENZA

Recognized by the Chair, Rep. Atienza pointed out that although a quorum was present, only 197

Members were in the Session Hall; and that the Secretariat's count was inaccurate.

REMARKS OF REP. GULLAS

With the permission of the Chair, Rep. Gullas stated for the record that the official Roll Call count was 219 Members.

The Chair noted the same.

APPROVAL OF THE JOURNAL

On motion of Rep. Gullas, there being no objection, the Body approved Journal No. 74, dated February 22, 2017.

Thereupon, the Chair recognized Rep. Marlyn B. Alonte on a matter of personal and collective privilege.

MANIFESTATION OF REP. DAZA

Before Rep. Alonte could deliver her speech, the Chair recognized Rep. Raul A. Daza who stated that Journal No. 74 contained an error on page 11 under the heading, "REMARKS OF REP. DAZA" because what was written thereon was the opposite of what he had actually said.

SUSPENSION OF SESSION

On motion of Rep. Gullas, the Chair suspended the session at 5:12 p.m.

RESUMPTION OF SESSION

The session resumed at 5:14 p.m.

Rep. Juan Pablo "Rimpy" P. Bondoc thereupon said that Rep. Alonte had the floor to deliver her question of privilege.

QUESTION OF PRIVILEGE OF REP. ALONTE

In response to allegations that she bribed some drug convicts to retract their testimonies against Senator Leila De Lima who had been arrested on drug charges, Rep. Alonte stressed that she did not subscribe to illegal acts and will never undermine the truth because she supported the Duterte Administration's aim to fight drugs, corruption, and criminality. She said that the accusations were baseless and false and unjustly affected the reputation not only of her family but also of her constituents and the Chamber

itself. She pointed out that for the last 19 years in public service, her only purpose was to serve with dignity, honesty, and sincerity.

Rep. Alonte however stressed that under the principle of good governance, the people still had the right to ask questions. She added that in spite of her pain and difficulty, she understood that the party she fought hard for and belonged to was simply practicing transparency, nonpartisanship, and fairness. She opined that she will obtain justice under the current Administration; and urged the nation to support, encourage, and believe in unity, peace, and the triumph of good over evil. She also thanked her colleagues for their love and support and stated that she was a proud member of the 17th Congress.

ACKNOWLEDGMENT OF GUESTS

At this point, Rep. Garin (R.) acknowledged the presence in the Session Hall of guests of Reps. Lorna P. Bautista-Bandigan and Vilma Santos-Recto.

MANIFESTATION OF REP. BONDOC

Recognized by the Chair, Rep. Bondoc reiterated Rep. Daza's manifestation regarding page 11 of Journal No. 74, dated February 22, 2017. He then said that under the caption, "REMARKS OF REP. DAZA," the statement should have read as follows: AT THIS POINT, REP. DAZA SAID THAT HE WANTED NOMINAL VOTING.

The Chair took note of Rep. Bondoc's manifestation.

Thereupon, on motion of Rep. Bondoc, the Chair recognized Rep. Atienza.

MANIFESTATION OF REP. ATIENZA

Rep. Atienza said that during the session on Wednesday, February 22, 2017, he had raised a query in support of Rep. Daza's position on Section 54 of the amended Provisional Rules of the House regarding the motion to close a debate. He said that he had insisted that three Members of the Majority be allowed to speak in favor of the Bill and two Members of the Minority be allowed to speak against it, in accordance with Section 54. He stressed that he had never agreed that the voting should continue because the debate had not yet started and because Section 54 did not talk about a *viva voce* vote right away but an initial decision on a motion to close the debate or not, with three Members of the Majority defending the motion and two Members of the Minority opposing it. He concluded that Section 54 was not followed and the *viva voce* voting was not in accordance therewith.

Rep. Atienza then pointed out that Journal No. 74, dated February 22, 2017, did not include his opposition to the aforesaid voting. He requested the Majority Leader to make the necessary corrections in the Journal in order to reflect the points he had raised, because it was important for the Body to follow the Rules.

Rep. Bondoc took note of the concerns of Rep. Atienza whom he referred to as the last survivor of the Plaza Miranda bombing in 1971, and said that he will address the latter's concerns after reviewing the transcripts and Journal of the aforesaid date.

Rep. Atienza said that he will continue to fight for democracy, freedom, and liberty.

With 224 affirmative votes, no negative votes, and no abstentions, the Body approved on Third Reading the aforementioned House Bills.

MANIFESTATION OF REP. LAGMAN

Recognized by the Chair, Rep. Edcel C. Lagman manifested his desire to move for the reconsideration of the approval of a motion made in the previous session.

SUSPENSION OF SESSION

On motion of Rep. Bondoc, the session was suspended at 6:35 p.m.

RESUMPTION OF SESSION

The session resumed at 6:37 p.m.

On motion of Rep. Bondoc, the Chair recognized Rep. Lagman anew.

MOTION OF REP. LAGMAN

Rep. Lagman moved to reconsider the Body's approval of the Majority Leader's motion to terminate the period of sponsorship and debate on House Bill No. 4727 during the session of Wednesday, February 22, 2017. He said that he voted with the Majority on said session day in order to file his motion for reconsideration on the succeeding session day because his objection to close the period of sponsorship and debate during said session was not recognized by the then Presiding Officer. As he further recalled that the Presiding Officer who submitted the Majority Leader's motion for voting stated that no Member objected thereto, Rep. Lagman clarified that he and Rep. Daza raised their objection and the latter even rose to raise another question.

He thereafter asked for five minutes to explain his motion for reconsideration.

REMARKS OF REP. BONDOC

Rep. Bondoc, in response, referred to Section 103 of the amended Provisional Rules of the House which provided that a Member who voted with the Majority may move for the reconsideration of a measure, report or motion that was approved, adopted or lost. He stressed that from Rep. Lagman's own statements, he did not vote in approval of the motion to terminate the period of sponsorship and debate on House Bill No. 4727; hence, his motion for reconsideration was not in order.

MOTION OF REP. BONDOC

Rep. Bondoc thereupon moved to adjourn the session.

OBJECTION OF REP. LAGMAN

Rep. Lagman objected to the motion of Rep. Bondoc and stated that the latter was not listening to his statement that he voted with the Majority precisely to entitle him to file a motion for reconsideration that session day.

REMARKS OF THE CHAIR

The Chair stated that there was a motion to adjourn the session.

REMARKS OF REP. LAGMAN

Rep. Lagman stated that he was entitled to file his motion during the day's session, and objected to adjourning the session before he was finished with his statement.

ADJOURNMENT OF SESSION

Thereafter, as previously moved by Rep. Bondoc, the Chair adjourned the session until four o'clock in the afternoon of Tuesday, February 28, 2017.
