TO THE COMMITTEE ON RULES

ACKNOWLEDGMENT OF GUESTS

At this point, Majority Leader Andaya acknowledged the presence in the Session Hall of the guests of Reps. Manuel Luis T. Lopez and Jeffrey D. Khonghun.

ELECTION OF MAJORITY MEMBERS

The Majority Leader then stated that the Office of the Speaker had received a letter from Rep. Reynaldo V. Umali expressing his intent to join the Minority thereby vacating his position as Chairperson of the Committee on Justice. In view thereof, on motion of Majority Leader Andaya on behalf of the Majority, there being no objection, the Body elected Rep. Doy C. Leachon as Chairperson of said Committee.

Likewise, on motion of Majority Leader Andaya, on behalf of the Majority, there being no objection, the Body elected Rep. Aurora Enerio Cerilles vice Rep. Rodolfo T. Albano III to the Commission on Appointments, representing the Nacionalista Party.

TERMINATION OF THE INTERPELLATIONS ON THE PRIVILEGE SPEECH OF REPRESENTATIVE QUIMBO

Thereupon, on motion of Majority Leader Andaya, there being no objection, the Body terminated the interpellations on the privilege speech of Rep. Romero “Miro” S. Quimbo.

MOTION TO RECOGNIZE REPRESENTATIVE SUAREZ AS MINORITY LEADER

Majority Leader Andaya thereafter moved for a division of the House on his motion to recognize Rep. Danilo E. Suarez as the Minority Leader of the House.

REMARKS OF MAJORITY LEADER ANDAYA

Majority Leader Andaya stated that the Body was in the process of voting and cannot be interrupted. He then requested the Chair to proceed with the *viva voce* voting on his motion.

VIVA VOCE VOTING ON THE MOTION TO RECOGNIZE REPRESENTATIVE SUAREZ AS MINORITY LEADER

Thereupon, the Chair called for a *viva voce* voting on the motion of Majority Leader Andaya to recognize Representative Suarez as the Minority Leader of the House, and with majority of the Members voting in favor of the motion, the same was carried.

SUSPENSION OF SESSION

The session was suspended at 3:29 p.m. upon motion of Majority Leader Andaya.

RESUMPTION OF SESSION

The session resumed at 3:37 p.m.

ACKNOWLEDGMENT OF GUESTS

Thereupon, Majority Leader Andaya acknowledged the presence in the Session Hall of the guests of Rep. Manuel T. Sagarbarria.

Thereafter, on motion of Majority Leader Andaya, the Chair recognized Rep. Rodolfo C. Fariñas.

MANIFESTATION OF REPRESENTATIVE FARIÑAS

Representative Fariñas inquired how his vote was recorded and the Chair informed him that the voting called for was by *viva voce*. He then manifested for the record that he was voting against the motion to recognize Representative Suarez as the Minority Leader of the House.

The Chair noted the manifestation.

Thereafter, on motion of Majority Leader Andaya, the Chair recognized Rep. Edcel C. Lagman.

MANIFESTATION OF REPRESENTATIVE LAGMAN

Likewise getting the same reply from the Chair as to how his vote was recorded, Representative Lagman then manifested his vote of abstention on the motion just approved by the House, explaining that the recognition of the Minority Leader is not subject to the approval or disapproval of the Body.

He underscored that the Rules of the House provides that the election of the Minority Leader should be done only by the members of the Minority; the recognition of the Minority Leader could never be subject to the approval or disapproval of the plenary having a mixed composition; and what had just transpired was an obvious violation of said Rules. He requested that his manifestation be put on record.

The Chair noted Representative Lagman's manifestation.

On motion of Majority Leader Andaya, the Chair recognized Representative Quimbo for his manifestation.

MANIFESTATION OF REPRESENTATIVE QUIMBO

Representative Quimbo manifested that since the motion had already been acted upon, and with same reasons as presented by Representative Lagman, he would like to submit and be put on record his continuing objection to the recognition of Representative Suarez as the Minority Leader because

it was illegal, not in due course, and an indirect violation of the Supreme Court (SC) decision on the case of *Baguilat vs. Alvarez*. He added that while everybody wanted orderly proceedings devoid of any legal question, they will have to take the necessary recourse where it was needed so as to clear the cloud hanging over the proceedings of the House of Representatives.

The Chair likewise noted the manifestation.

On motion of Majority Leader Andaya, the Chair recognized Representative Erice for his manifestation.

MANIFESTATION OF REPRESENTATIVE ERICE

Representative Erice stated that he was supposed to be the last interpellator on a speech delivered the previous session but was however prevailed upon to defer his interpellation until the next session. Given that the Body already terminated the interpellations on the matter, he asked if he could instead speak on a matter of personal and collective privilege.

REMARKS OF MAJORITY LEADER ANDAYA

Before granting Representative Erice's request, Majority Leader Andaya asked that the Body allow first the other Members who wished to make a manifestation regarding the just concluded votation, a chance to raise their points before proceeding with the former's question of privilege.

MANIFESTATION OF REPRESENTATIVE DE VERA

Recognized by the Chair upon the Majority Leader's motion, Representative De Vera initially manifested his objection, with a heavy heart, to the election of Representative Suarez as the Minority Leader whom he considered as a very good leader of the Minority bloc during the former's stint as a member of the Minority under the latter's watch. He expressed disappointment that the Members had not faithfully obeyed the Rules of the House as stipulated in its Preamble. This, as he emphasized that Rules II and III clearly deal with the membership and election of officers of the House, respectively.

The Chair noted the manifestation.

On motion of Majority Leader Andaya, the Chair next recognized Rep. Gabriel H. Bordado Jr. for his manifestation.

MANIFESTATION OF REPRESENTATIVE BORDADO

Expressing his objection to the recognition of Representative Suarez as Minority Leader, Representative Bordado said that he had listened intently to the lengthy and sometimes torrid discussions on the issue of the Minority leadership and it was Representative Quimbo's argument that stood out for its sheer logic and lucidity. He quoted and agreed to Representative Quimbo's contentions on who shall form part of the Majority and Minority blocs, what determines the membership status of those who abstained during the voting for the speakership, and who would elect the Minority Leader based on Section 8, Rule II of the House Rules and the SC ruling in the case of *Baguilat vs. Alvarez*.

The Chair likewise noted the manifestation.

On motion of Majority Leader Andaya, the Chair recognized anew Representative De Vera.

MANIFESTATION OF REPRESENTATIVE DE VERA

Representative De Vera relayed that in the morning of August 2, 2018 at his office, he was unanimously elected as Minority Leader by the following members of the Minority: Representatives Pantaleon D. Alvarez, Rodolfo C. Fariñas, Rodolfo T. Albano III, Lucy T. Gomez, Arnel U. Ty, Juan Pablo "Rimpy" P. Bondoc, Aileen C. Radaza, Reynaldo V. Umali, Roger G. Mercado, Manuel Monsour T. Del Rosario III, Mauyag "Jun" B. Papandayan Jr., and Ruwel Peter S. Gonzaga.

Representative De Vera requested that said names be put on record.

After taking note of Representative De Vera's manifestation, the Chair next recognized Rep. Arnel "Ka Ayik" B. Casilao upon motion of Majority Leader Andaya.

MANIFESTATION OF REPRESENTATIVE CASILAO

Representative Casilao stated for the record and on behalf of his group, the Makabayan bloc, their negative vote on the recognition of the Minority Leader. He pointed out that it was the first time in the history of the House of Representatives that the

job to select a Minority Leader has been decided upon by all, if not majority of the Members present in the Plenary Hall. He added that it should not be the intent and interpretation of the House Rules that they approved in July 2016 as he expressed dismay that the Majority had obviously used the tyranny of numbers in order to twist the Rules and obtain their desired outcome.

The Chair noted the manifestation

On motion of Majority Leader Andaya, the Chair subsequently recognized Representative Erice who delivered a question of personal and collective privilege instead of a manifestation.

QUESTION OF PRIVILEGE OF REPRESENTATIVE ERICE

Representative Erice shared the concern of his colleagues regarding the media reports affecting the integrity and credibility of the House of Representatives due to the Minority leadership dispute, which was the same concern expressed in a question of privilege delivered by Rep. Rodante D. Marcoleta during the previous session.

Representative Erice posited the importance of the Rules of the House in the conduct of their daily proceedings and cases of conflict, as well as the need for a credible Minority, a proactive Majority, and quality legislation to maintain the integrity of the House of Representatives. He then quoted the late President Diosdado Macapagal's statement about doing acts that should not just be legal but moral as well. In an attempt to elaborate his points, Representative Erice requested to proceed with a video clip presentation.

REMARKS OF MAJORITY LEADER ANDAYA

Majority Leader Andaya however said that said video had not been cleared for presentation and cannot be shown at that time. He added that it was not submitted to him and he had not fully reviewed it.

REMARKS OF THE CHAIR

The Chair remarked that the video cannot be presented as requested by Representative Erice.

QUESTION OF PRIVILEGE OF REPRESENTATIVE ERICE (Continuation)

Continuing with his speech, Representative Erice opted to explain to the Body the contents of

the video clip that was supposed to be shown. He related that it was during an interview with CNN Philippines host Pinky Webb where Representative Suarez responded to questions in a way that had compromised the functions of the Minority for check and balance, and how such interview revealed Representative Suarez' real motive in leading the Minority bloc.

In the said interview, according to Representative Erice, Representative Suarez allegedly uttered that 32 Members were applying to him as members of the Minority because of his known closeness to the new Speaker; he wanted to retire from this Congress as its Minority Leader; and he did not want to leave his office because he spent for its renovation.

Representative Erice asked how the credibility of the House can be maintained if personal reasons are used in electing a Minority Leader. Nevertheless, he stressed that he and the genuine Minority will continue to provide checks and balance in the Chamber even if they are removed from their seats or positions. This, as he disclosed that in 2018, he and other Congressmen who merely wanted to assert their independence did not receive their project budgets.

REMARKS OF REPRESENTATIVE SUAREZ

On motion of Majority Leader Andaya, the Chair recognized Representative Suarez who clarified that his remarks about his pride in his office and accomplishments were made after the CNN interview and off the record and were based on a desire to leave a legacy. He added that 80% of the work of the Minority is to check the performance of the Executive Department and he did and will continue to do the same for the 2018 and 2019 budget hearings, respectively. He stressed anew that his relationship with the leadership has always been constructive and not destructive and asked why the House should use the remaining months of the 17th Congress to quarrel despite many important issues it had to consider.

REMARKS OF REPRESENTATIVE ERICE

With the permission of the Chair, Representative Erice said that the aforementioned interview was a live event and could be watched in CNN through YouTube.

INTERPELLATION OF REPRESENTATIVE MARCOLETA

On motion of Majority Leader Andaya, the Chair then recognized Representative Marcoleta

who asked whether the selection of a Minority Leader should be based on who was a better fiscalizer. Representative Erice clarified that the subject of his question of privilege was not the legality but morality of allowing a Member, who was very close to the Speaker and voted and campaigned for her, to be the Minority Leader; and that Representative Suarez was a member of the Majority and shared the Speaker's advocacy.

At this point, Representative Marcoleta asked how there can be a winner in the speakership when there was only one candidate or nominee for the same. He said that what happened was that Speaker Gloria Macapagal-Arroyo did not win but simply got the majority votes and became qualified to replace the incumbent Speaker.

Representative Erice remarked that many Members ran unopposed and won the elections and asked how Speaker Macapagal-Arroyo could have been elected if Representative Marcoleta says there was no election. He emphasized that in the pertinent session day, motions were made to declare the speakership vacant and to open the period of nomination and that nominal voting had occurred. He clarified that he was interested not on the legality but morality in the election of the Minority Leader.

REFERRAL OF THE SPEECH OF REPRESENTATIVE ERICE

On motion of Majority Leader Andaya, there being no objection, the Body referred Representative Erice's speech to the Committee on Rules.

UNFINISHED BUSINESS: COMMITTEE REPORT NO. 739 ON HOUSE BILL NO. 7735

On motion of Majority Leader Andaya, there being no objection, the Chair then considered on Second Reading House Bill No. 7735 contained in Committee Report No. 739 as reported out by the Committees on Agriculture and Food, Ways and Means, and Appropriations.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit: "AN ACT REPLACING THE QUANTITATIVE IMPORT RESTRICTIONS ON RICE WITH TARIFFS AND CREATING THE RICE COMPETITIVENESS ENHANCEMENT FUND."

ACKNOWLEDGMENT OF GUESTS

Before proceeding with the consideration of said Bill, Rep. Cristina "Chiqui" Roa-Puno acknowledged the presence in the Session Hall of

the guests of Reps. Raymond Democrito C. Mendoza, Ma. Theresa V. Collantes, Strike B. Revilla, Tom S. Villarín, Mario Vittorio “Marvey” A. Mariño, Amihilda J. Sangcopan, Romero “Miro” S. Quimbo, and Jorge “Bolet” Banal.

SUSPENSION OF SESSION

The Chair then declared a recess at 4:19 p.m. upon Representative Roa-Puno’s motion.

RESUMPTION OF SESSION

The session resumed at 4:21 p.m.

Upon resumption of session, Representative Roa-Puno stated that the parliamentary status was that the Body was considering amendments to House Bill No. 7735.

PERIOD OF AMENDMENTS

There being no Committee amendments, on successive motions of Representative Roa-Puno, there being no objection, the Body proceeded to consider individual amendments, and the Chair recognized Rep. Jose T. Panganiban Jr., CPA, LLB, Chairperson of the Committee on Agriculture and Food, to sponsor the measure and Representative Lagman, to present his individual amendments.

AMENDMENTS OF REPRESENTATIVE LAGMAN

As proposed by Representative Lagman and accepted by the Sponsor, there being no objection, the Body approved the amendments in Sections 6, 9, and 15 of the Bill.

Representative Lagman also stated for the record that with the approval of his last amendment, the proceeds from the proposed Rice Fund will no longer be incorporated in the General Appropriations Act as these would be automatically appropriated.

At this juncture, on motion of Representative Roa-Puno, the Chair recognized Rep. Carlos Roman L. Uybarreta for his individual amendments.

AMENDMENTS OF REPRESENTATIVE UYBARRETA

On motion of Representative Uybarreta and accepted by the Sponsor, there being no objection, the Body approved the amendments in Section 17; the insertion of a new Section 18 on “Implementing Rules and Regulations”; and in view thereof, the renumbering of the affected sections.

TERMINATION OF PERIOD OF AMENDMENTS

There being no other amendments, on motion of Representative Roa-Puno, there being no objection, the Body terminated the period of amendments.

MOTION OF REPRESENTATIVE ROA-PUNO

At this point, Representative Roa-Puno moved to approve on Second Reading House Bill No. 7735.

QUESTION OF QUORUM

Rep. Antonio L. Tinio asked whether a quorum exists considering that the Body was about to vote.

SUSPENSION OF SESSION

The Chair *motu proprio* suspended the session at 4:33 p.m.

RESUMPTION OF SESSION

The session resumed at 4:42 p.m. and on motion of Representative Roa-Puno, the Chair recognized Representative Tinio.

WITHDRAWAL OF REPRESENTATIVE TINIO’S MOTION

Seeing that other Members were coming back to the floor, Representative Tinio withdrew his previous question of quorum.

SUSPENSION OF CONSIDERATION ON SECOND READING OF HOUSE BILL NO. 7735

On motion of Representative Roa-Puno, there being no objection, the Body temporarily suspended the consideration on Second Reading of House Bill No. 7735.

BUSINESS FOR THE DAY: COMMITTEE REPORT NO. 752 ON HOUSE BILL NO. 7773

On another motion of Representative Roa-Puno, there being no objection, the Body considered on Second Reading House Bill No. 7773 contained in Committee Report No. 752 as reported out by the Committees on Poverty Alleviation, and Appropriations.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

“AN ACT INSTITUTIONALIZING THE PANTAWID PAMILYANG PILIPINO PROGRAM (4Ps) TO REDUCE POVERTY AND PROMOTE HUMAN CAPITAL DEVELOPMENT AND PROVIDING FUNDS THEREFOR.”

As copies of the Bill had been distributed to the Members, on motion of Representative Roa-Puno, there being no objection, the Body dispensed with the reading of the text of the measure without prejudice to its insertion into the Record of the House.

Thereafter, on motion of Representative Roa-Puno, the Chair recognized Rep. Raymond Democrito C. Mendoza, Chairperson of the Committee on Poverty Alleviation, for his sponsorship speech.

SPONSORSHIP SPEECH OF REPRESENTATIVE MENDOZA

Representative Mendoza said that House Bill No. 7773 seeks to make the Pantawid Pamilyang Pilipino Program (4Ps) a regular program of the government to help 60 percent of the total number of extremely poor households in the country.

He then expounded on the issues surrounding 4Ps which the measure seeks to address, to wit: 1) correct double entries, data errors and delayed cash releases, and prevent the occurrence of unpaid beneficiaries; 2) remedy the deficiencies in the basic services for children for both education and health and to ensure that they remain healthy and stay in school; 3) involve the private sector and civil society organizations in monitoring the implementation of the program and in providing feedback for proper action; and 4) strengthen the mechanism of accountability and transparency by requiring the Department of Social Welfare and Development (DSWD) to post on the website a report of financial disclosures, information about beneficiaries, and to submit the same to Congress.

In recognizing that the 4Ps alone cannot guarantee poverty alleviation, Representative Mendoza believed that in convergence with other social protection programs particularly on health, education, housing, and livelihood, 4Ps should be implemented until the poor are able to stand on their own. He then called on his colleagues to unanimously push for the passage of the bill to give a fighting

chance for the next generation of marginalized Filipinos.

Thereafter, on motion of Representative Roa-Puno, the Chair recognized Rep. Tom S. Villarín for his sponsorship speech.

SPONSORSHIP SPEECH OF REPRESENTATIVE VILLARIN

Speaking in Filipino, Representative Villarín initially said that according to World Bank data, poverty rate in the Philippines decreased by five percent from 2006 to 2015 due to the government's Conditional Cash Transfer Program or 4Ps. According to a number of studies, Representative Villarín stated that the 4Ps is considered as one of the best targeted social safety nets in the world considering that the program maintains continuous education and treatment for the poor especially the children and their mothers. He then called on his colleagues for the immediate enactment of the 4Ps measure.

SUSPENSION OF CONSIDERATION ON SECOND READING OF HOUSE BILL NO. 7773

On motion of Majority Leader Andaya, there being no objection, the Body suspended the consideration on Second Reading of House Bill No. 7773.

On further motion of Majority Leader Andaya, there being no objection, the Body resumed the consideration on Second Reading of House Bill No. 7735 contained in Committee Report No. 739 as reported out by the Committees on Agriculture and Food, Ways and Means, and Appropriations, entitled: “AN ACT REPLACING THE QUANTITATIVE IMPORT RESTRICTIONS ON RICE WITH TARIFFS AND CREATING THE RICE COMPETITIVENESS ENHANCEMENT FUND.”

APPROVAL ON SECOND READING OF HOUSE BILL NO. 7735

Thereupon, on motion of Majority Leader Andaya, there being no objection, the Body approved on Second Reading House Bill No. 7735 through *viva voce* voting.

Thereafter, on motion of Representative Roa-Puno, the Chair recognized Rep. Victor A. Yap, Chairperson of the sponsorship Committee, for his sponsorship remarks.
