TO THE COMMITTEE ON RULES

ACKNOWLEDGMENT OF GUESTS

Representative Salo then acknowledged the presence in the Session Hall of guests of Rep. Arthur C. Yap.

THE PRIVILEGE HOUR

The day being a Monday, on motion of Representative Salo, there being no objection, the Chair declared a Privilege Hour and thereafter recognized Rep. Arnolfo “Arnie” A. Teves Jr. for his privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE TEVES

Observing what had transpired in the recent barangay elections, Representative Teves opined that the anti-dynasty provision of the Constitution was faulty. He pointed out that public positions are mandated by the people through elections and are not inherited, and that term limits and similar prohibitions curtail the right or freedom of the people to choose and elect their officials.

At this juncture, Deputy Speaker Abu relinquished the Chair to Deputy Speaker Eric D. Singson.

On motion of Representative Salo, the Chair recognized Rep. Vincent “Bingbong” P. Crisologo for his interpellation.

INTERPELLATION OF REPRESENTATIVE CRISOLOGO

After Representative Crisologo said that he shared the views of Representative Teves, he and the latter then agreed that all voters, regardless of age, should be allowed to vote for the chairmen and councilors of the Sangguniang Kabataan (SK). He however qualified that the candidates for the SK positions should be restricted to those between 18 to 24 years of age.

REFERRAL OF REPRESENTATIVE TEVES’ PRIVILEGE SPEECH

Thereupon, on motion of Representative Salo, there being no objection, the Body referred the privilege speech of Representative Teves to the Committee on Rules for its appropriate action.

Thereafter, on motion of Representative Salo, the Chair recognized Deputy Speaker Abu for his privilege speech.

PRIVILEGE SPEECH OF DEPUTY SPEAKER ABU

Deputy Speaker Abu took the floor to expose the circumvention of Pilipinas Shell Petroleum Corporation (Shell) to pay taxes for the last 13 years,

which has caused the government to lose billions of pesos in revenues.

He pointed out that Shell changed its declaration of imported gasoline from “catalytic cracked gasoline” (CCG) and “light catalytic cracked gasoline” (LCCG) to “tetra propylene” in 2004 and to “alkylate for blending component” in 2010, thus avoiding coverage from excise taxes. Narrating the sequence of events, he said that the Bureau of Customs (BOC) and Bureau of Internal Revenue (BIR) started demanding and collecting the proper taxes from Shell since 2009; the Court of Tax Appeals (CTA) subsequently ruled that the aforesaid shipments were subject to tax and ordered Shell to pay billions of tax dues; Shell then filed petitions for review with the CTA, arguing that their imports were raw materials; and the Supreme Court thereafter issued a temporary restraining order in favor of Shell and against the BIR and BOC.

At this point, Deputy Speaker Abu pointed out that Shell is currently enjoying benefits at the expense of the government’s loss of ₱55 million every month on alkylate shipments, on top of the ₱7 billion that the company owes in taxes for CCG and LCCG shipments from 2004 to 2009 exclusive of penalties. He stressed that Shell should be held accountable for years of technical smuggling and should be made an example that no one is above the law; and asked that the matter be referred to the appropriate committee for an inquiry in aid of legislation.

REFERRAL OF DEPUTY SPEAKER ABU’S PRIVILEGE SPEECH

On motion of Representative Salo, there being no objection, the Body referred Deputy Speaker Abu’s privilege speech to the Committee on Rules for its appropriate action.

At this juncture, Deputy Speaker Singson relinquished the Chair to Deputy Speaker Abu.

On further motion of Representative Salo, the Chair recognized Rep. Gary C. Alejano for his privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE ALEJANO

Representative Alejano likened China’s Belt and Road Initiative (BRI), which aims to connect China over land and water to the economic circles in Asia, Europe, and Africa through a trade and infrastructure network with a capital investment of \$8 trillion, as a wolf in sheep’s clothing. He said that

while China's generosity might seem to be an act of benevolence towards its relatively disadvantaged neighbors, it is nothing but a strategy (1) to extend its political, economic, and military power beyond its borders and above international rules, norms, and conventions, and (2) to trap poor nations into massive debt and subsequently seize their natural resources, strategic assets, and territories as collateral, just to prop itself as the new world leader.

Representative Alejano then pointed out that the Philippines was not yet one of the 23 countries identified as in risk of debt distress due to BRI financing. He however observed that the Duterte Administration seemed eager for Chinese loans in order to fund its mega infrastructure projects under its Build, Build, and Build Program.

After citing the experience of other poor countries who availed of loans from China, Representative Alejano cautioned the Philippines from doing the same in view of the absence of multilateral agreements, transparency, and defined frameworks as well as the high interest rates and ambiguity of the projects involved. He warned against what he called a debt-trap diplomacy that would erode the country's chance of staking its rightful claims in the West Philippine Sea; disagreed with the Administration's pronouncement that the Chinese loans "have no strings attached"; and stressed that Congress should assert its power of congressional oversight over said loans.

Thereupon, Representative Alejano said that he took the floor not to lambast the supporters of the Duterte Administration but to convince them to be more cautious in their undertakings with China as this would affect the national foreign policy. He also underscored that the country had trusted allies like Japan and the United States of America from whom it could borrow funds; had other reliable trusted sources of money; and could enhance tax collection efficiency in order to raise public funds.

MOTION OF REPRESENTATIVE DEFENSOR

At this point, Rep. Defensor moved to refer Representative Alejano's speech to the Committee on Rules, but subsequently withdrew his motion to give way to Rep. Tom S. Villarín's interpellation.

INTERPELLATION OF REPRESENTATIVE VILLARIN

To his colleague's initial queries, Representative Alejano said that China had pledged to lend

money to the country but that according to the National Economic and Development Authority, only one loan agreement had been signed.

After stressing that the Congress should verify said loan, Representative Alejano stressed that the BRI was a strategy to control Third World countries and questioned the government's foreign policy regarding China considering the latter's continued militarization in the West Philippine Sea. He agreed with Representative Villarín that Congress should investigate the matter and that the Departments of Foreign Affairs (DFA) and Defense (DND) must explain Philippine foreign and defense policy as regards China.

Representative Villarín then asked about the implications to national security of the entry of a Chinese telecommunications company into the country and about the benefits from trade relations with China. Representative Alejano said that joint venture agreements with China should be looked into; the country imported more products from China than it exported to the same; and due to the government's open-door policy, illegal drugs and casino money from China have entered and proliferated in the country.

REMINDER FROM THE CHAIR

With the indulgence of Representatives Alejano and Villarín, the Chair reminded the Body that the Privilege Hour had already expired.

EXTENSION OF THE PRIVILEGE HOUR

Thereupon, on motion of Representative Defensor, there being no objection, the Body extended the Privilege Hour for 40 minutes.

INTERPELLATION OF REPRESENTATIVE VILLARIN (Continuation)

At this point, Representatives Villarín and Alejano agreed that overdependence on China and its products may have national security implications for the Philippines. The former suggested that the House conduct a Question Hour to which finance, defense, and trade officials will be invited to shed light on the relationship between the two countries; while the latter stressed that as the Philippines engages China, it should not forget the national interest.

REFERRAL OF THE PRIVILEGE SPEECH OF REPRESENTATIVE ALEJANO

On motion of Representative Defensor, there being no objection, the Body referred Representa-

tive Alejano's privilege speech and the interpellations thereon to the Committee on Rules.

PRIVILEGE SPEECH OF REPRESENTATIVE OLIVAREZ

Recognized by the Chair on motion of Representative Defensor, Rep. Eric L. Olivarez, in behalf of Rep. Gus S. Tambunting and City Mayor Edwin Olivarez, rose to speak about the economic state of Parañaque City in commemoration of its 20th founding anniversary as a city on February 15, 2018.

Attributing the progress of Parañaque to the efforts of the incumbent administration and the citizens, he initially cited its achievements in education, infrastructure, and the economy; and its development through good governance, proper investment, and dedicated service from a simple municipality to a new and modern city.

After explaining the meaning of the city's slogan, "Towards a BAGONG Parañaque," Representative Olivarez enumerated their completed as well as ongoing projects and programs such as in education, protection of women and children, and health; and discussed how good governance has resulted in the allocation of needed funds for the barangays, a decrease in the crime rate, quick crisis and disaster response from government agencies, and implementation of public-private partnership programs. He also mentioned facts and statistics on housing, employment, and public infrastructure in the city.

At this juncture, Deputy Speaker Abu relinquished the Chair to Representative Defensor.

Thereupon, Representative Olivarez expressed belief that the real measure of growth and prosperity is the condition of every person's physical and spiritual well-being.

At this point, Representative Defensor relinquished the Chair to Deputy Speaker Abu.

REMARKS OF THE CHAIR

The Chair congratulated Representative Olivarez on the 20th anniversary of Parañaque City and remarked that the latter's brother was a good mayor.

REMARKS OF REPRESENTATIVE SALO

Representative Salo likewise congratulated Representative Olivarez on the 20th anniversary of Parañaque City.

REFERRAL OF REPRESENTATIVE OLIVAREZ' PRIVILEGE SPEECH

On motion of Representative Salo, there being no objection, the Body referred the privilege speech of Representative Olivarez to the Committee on Rules for its appropriate action.

On motion of Representative Salo, the Chair recognized Rep. France L. Castro for her privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE CASTRO (F.L.)

Representative Castro first acknowledged the dedication and service rendered by public school teachers, Department of Education (DepEd) personnel, and other public and private citizens during the recent barangay and SK elections. She also adverted to the Election Service Reform Act (ESRA) or Republic Act (R.A.) No. 10756 authored by Rep. Antonio L. Tinio which (1) made the provision of services by public school teachers during elections voluntary and not anymore mandatory; (2) allowed private school teachers and other government employees and other qualified citizens to render election services as well; and (3) increased said volunteers' honoraria, allowances, and compensation package which includes legal assistance, medical benefits, and insurance.

EXTENSION OF PRIVILEGE HOUR

With the indulgence of Representative Castro (F.L.), on motion of Representative Defensor, there being no objection, the Chair extended the Privilege Hour for another 45 minutes.

PRIVILEGE SPEECH OF REPRESENTATIVE CASTRO (F.L.) (Continuation)

Representative Castro then stressed that in the recently concluded barangay and SK elections, the Commission on Elections (Comelec) and DepEd were not able to ensure that public school teachers and department personnel were voluntarily appointed to render election services and were not able to implement an information campaign thereon. She added that many election workers did not receive honoraria and travel allowances while others received cash cards that were not yet funded.

After asking the Comelec to stop using the cash card system, Representative Castro called for the immediate release of all honoraria and transportation allowances due to the teachers as well as the return of the five percent income tax that was deducted from the same. She also asked that medical

and legal assistance or indemnification be provided to some teachers who experienced health problems and harassment during the recent elections; that the Comelec make such an automatic provision in the 2019 elections; and that the monetary benefits and allowances of election workers be increased.

She stressed that teachers and other election officers are exposed to extreme difficulties and are always at risk for their high integrity and sense of service and these do not make sense if agencies such as the Comelec, DepEd, and BIR do not implement the law.

REFERRAL OF REPRESENTATIVE CASTRO'S (F.L.) PRIVILEGE SPEECH

On motion of Representative Defensor, there being no objection, the Body referred the privilege speech of Representative Castro to the Committee on Rules for its appropriate action.

The Chair then recognized Rep. Sarah Jane I. Elago for her privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE ELAGO

Representative Elago cited the effects of the declaration of martial law in Mindanao and of the policies implemented for the last two years by the Duterte Administration, especially on the poor and underprivileged. She related the killing and torture of several lumad youths in Davao del Sur, Davao del Norte, and Compostela Valley as well as various instances of violence, harassment, forced evacuation, and bombings suffered by farmers, lumad communities, and schools. She stressed that such incidents were proof of the violations of the indigenous people's right to decent and peaceful living, to education, to self-determination, and to ancestral lands.

Subsequently, Representative Elago warned against the intervention of foreign powers in the country supposedly to fight terrorism. She relayed the youth sector's call for the end to martial law, American troop presence in the country, unequal treaties with other countries, and China's intrusion and militarization in Philippine territory. She urged the country to stand and unite for a sovereign foreign policy and for the national interest.

REFERRAL OF REPRESENTATIVE ELAGO'S PRIVILEGE SPEECH

On motion of Representative Defensor, there being no objection, the Body referred Representative Elago's privilege speech to the Committee on Rules for its appropriate action.

On further motion of Representative Defensor, the Chair recognized Rep. Carlos Isagani T. Zarate to deliver his privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE ZARATE

Speaking in Filipino, Representative Zarate focused on the declaration of martial law on May 23, 2017 in Marawi City, and called for the end thereof in Mindanao. He emphasized how together with the members of the Makabayan Bloc, they have expressed their strong objection to martial law because it would result to violence, killings, loss of residence, robbery, and forced evacuation. He lamented the devastation of Marawi City and the displacement of its residents; and the lack of government's concrete action to indemnify the victims, address the needs of civilian casualties, and end martial law.

As he expressed the desire of the Muslims to rehabilitate Marawi in a manner that is sensitive to their culture and religion, he cautioned against military abuse and inquired on the gains that were achieved by the government under martial law. He thereafter asked the Members to stand for their right in fighting for true justice, peace, and democracy in Mindanao.

REFERRAL OF REPRESENTATIVE ZARATE'S PRIVILEGE SPEECH

On motion of Representative Defensor, there being no objection, the Body referred Representative Zarate's privilege speech to the Committee on Rules for its appropriate action.

PRIVILEGE SPEECH OF REPRESENTATIVE GO (M.)

Recognized by the Chair on motion of Representative Defensor, Representative Mark O. Go spoke about the DepEd's policy reform of implementing the Enhanced Basic Education (K to 12) Program that has resulted in 1.2 million public senior high school students who were the pioneer graduates of the said curriculum.

He discussed whether the program has produced graduates with global skills and is geared towards utilitarianism or humanism; whether the DepEd can address the shortage in classrooms, teachers, and instructional materials; and whether the government has preempted the work force that should find its corresponding working stations in the world. He cited an opinion that preparedness should not be limited to the students' capacity to

work but also to the economy's ability to accommodate work.

REMINDER FROM THE CHAIR

The Chair stated that the Privilege Hour had already expired.

EXTENSION OF THE PRIVILEGE HOUR

On motion of Representative Defensor, there being no objection, the Body extended the Privilege Hour by 15 minutes.

PRIVILEGE SPEECH OF REPRESENTATIVE GO (M.)

(Continuation)

Thereupon, Representative Go expressed concern whether the K to 12 program is tailored to develop 21st century skills and is designed to be industry-driven. As he asked whether the economy is prepared to meet the influx of graduates, he enjoined his colleagues to revisit the purpose of the program.

REFERRAL OF REPRESENTATIVE GO'S (M.) PRIVILEGE SPEECH

Thereupon, on motion of Representative Salo, there being no objection, the Body referred the privilege speech of Representative Go to the Committee on Rules for its appropriate action.

Thereafter, on motion of Representative Salo, the Chair recognized Rep. Arlene D. Brosas for her privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE BROSAS

Speaking in Filipino, Representative Brosas spoke on the first year anniversary of the declaration of martial law on May 23, 2017 in Mindanao and focused on the negative effects of militarization therein such as the loss of innocent lives due to extrajudicial killings. She cited several incidents of human rights atrocities in Mindanao committed by elements of the Armed Forces of the Philippines (AFP) that resulted in violence, killings, bombings, displacement of residents, robbery, and forced evacuation.

Representative Brosas whereupon stated that unless martial law is lifted, said atrocities would continue and the situation in Mindanao would worsen. She called on the government to end martial law and to investigate human rights violations committed as a result thereof.

REFERRAL OF REPRESENTATIVE BROSAS' PRIVILEGE SPEECH

Thereupon, on motion of Representative Salo, there being no objection, the Body referred the privilege speech of Representative Brosas to the Committee on Rules for its appropriate action.

TERMINATION OF THE PRIVILEGE HOUR

Thereafter, on motion of Representative Salo, there being no objection, the Body terminated the Privilege Hour.

RATIFICATION OF THE CONFERENCE COMMITTEE REPORT ON HOUSE BILL NO. 6915 AND SENATE BILL NO. 1103

On motion of Representative Salo, there being no objection, the Body considered and subsequently ratified the Conference Committee Report on the disagreeing provisions of House Bill No. 6915 and Senate Bill No. 1103, establishing a campus of the Polytechnic University of the Philippines in Sابلayan, Occidental Mindoro.

DESIGNATION OF HOUSE CONFEREES ON CERTAIN HOUSE BILLS

On successive motions of Representative Salo, there being no objection, the Body designated the following Members to the Conference Committees to reconcile the disagreeing votes on the following House Bills:

1. House Bill No. 5367, reapportioning the Sixth and Seventh Legislative Districts of the Province of Cavite to create an additional legislative district to be known as the Eighth Legislative District of the Province of Cavite: Reps. Pedro B. Acharon Jr., Rene L. Relampagos, Luis "Jon-Jon" A. Ferrer IV, and Arlene B. Arcillas; and
