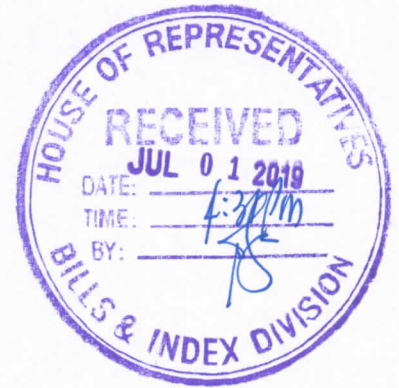

EXPLANATORY NOTE


This bill seeks to fulfill the vision of the Technical Education and Skills Development Authority (TESDA) in the development of the Filipino workforce with world-class competence and positive work values whether for deployment locally or abroad.

Also, this bill pursues the creation of TESDA Skills and Training and Accreditation Centers in San Jose City and Science City of Muñoz and in the municipality of Rizal, all in the Second District of Nueva Ecija.

The creation of the TESDA Center in San Jose City will cater to its 38 barangays, the one in the Science City of Muñoz will serve its 37 barangays while the TESDA Center in the municipality of Rizal will attend to its 26 barangays.

This will directly benefit the morale of the constituency in our district in general as well as its nearby municipalities by way of possible employment and livelihood opportunities meant to further improve their quality of life.

Accordingly, approval of this proposed measure, is strongly recommended.

**“AN ACT PROVIDING FOR THE ESTABLISHMENT OF THE TECHNICAL
EDUCATION AND SKILLS DEVELOPMENT AUTHORITY TRAINING AND
ACCREDITATION CENTERS IN THE CITIES OF SAN JOSE CITY, SCIENCE CITY
OF MUÑOZ AND IN THE MUNICIPALITY OF RIZAL, ALL IN THE SECOND
LEGISLATIVE DISTRICT OF NUEVA ECIIJA”**

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

SECTION 1. There is hereby created the Technical Education and Skills Development Authority (TESDA) Training and Accreditation Centers in the cities of San Jose City, Science City of Muñoz and in the Municipality of Rizal, Nueva Ecija.

Section 2. The amount for the effective implementation of this Act shall be included in the General Appropriations Act on the year following the approval of this Act and in every year thereafter.

Section 3. The TESDA shall formulate the necessary implementing rules and regulations for the implementation of this Act.

Section 4. Separability Clause. If for any reason, any section of the Act shall be deemed unconstitutional or invalid, the other sections or provisions thereof shall not be affected thereby and shall remain in full force and effect.

Section 5. Repealing Clause. All laws, executive orders, decrees, instructions, rules and regulations, contrary to or inconsistent with any provisions of this Act are hereby repealed or modified accordingly.

Section 6. Effectivity Clause. This Act shall take effect immediately upon its approval.
