EXPLANATORY NOTE

This bill seeks to separate the Langin National High School – Ronda National High School Poblacion Extension in Barangay Poblacion, Municipality of Ronda, Province of Cebu from the Langin National High School and convert it into an independent national high school to be known as the Ronda National High School.

Education is a lasting legacy far more important than any other asset. This sentiment motivates and inspires Filipinos to aim for a good education. This high regard by the people for quality education must be given support and attention by the government. Providing the Municipality of Ronda, particularly Barangay Poblacion, the basic school facilities necessary to enhance their quest for a quality education at the early stage of the learning process is the foremost assistance the government can offer to its citizens.

The elevation of the Langin National High School-Ronda National High School Poblacion Extension into a separate and independent educational institution will open greater opportunities to the youth and provide enough funds and adequate facilities to the school. Its conversion will greatly improve and promote the quality of education of the youth in the area thereby affording them better means of improving their quality of life.

In view of the foregoing, immediate approval of this bill is highly recommended.

5 **THE LANGIN NATIONAL HIGH SCHOOL, CONVERTING IT INTO AN**
6 **INDEPENDENT NATIONAL HIGH SCHOOL TO BE KNOWN AS**
7 **THERONDA NATIONAL HIGH SCHOOL, AND APPROPRIATING**
8 **FUNDS THEREFOR**

10 *Be it enacted by the Senate and House of Representatives of the Philippines in*
11 *Congress assembled:*

13 SECTION 1. The Langin National High School – Ronda National High
14 School Poblacion Extension in Barangay Poblacion, Municipality of Ronda,
15 Province of Cebu is hereby separated from the Langin National High School and
16 converted into an independent national high school to be known as the Ronda
17 National High School.

1 SEC. 2. All personnel, assets, liabilities and records of the Langin National
2 High School – Ronda National High School Poblacion Extension are hereby
3 transferred to and absorbed by the Ronda National High School.

4 SEC. 3. The Secretary of Education shall immediately include in the
5 Department's program the operationalization of the Ronda National High School,
6 the initial funding of which shall be charged against the current year's appropriation
7 for the Langin National High School – Ronda National High School Poblacion
8 Extension. Thereafter, the amount necessary for the continued operation of the
9 school shall be included in the annual General Appropriation Act.

10 SEC. 4. The Secretary of Education shall formulate the rules and regulations
11 implementing the provisions of this Act.

12 SEC. 5. This Act shall take effect fifteen (15) days after its publication in the
13 *Official Gazette* or in a newspaper of general circulation.
