
**EXPLANATORY NOTE**

This bill seeks to create the TESDA Skills and Accreditation Center in barangay Apulid, Municipality of Paniqui, in the province of Tarlac. To migrate it, in terms of its aims toward skills development of human resources, through the development of the Center, it will truly redound to the benefit of the youth in the area and the neighboring districts.

The availability of the training center shall provide the youth with the opportunity to empower themselves to be self-reliant and acquire new skills and techniques that enable them to earn a livelihood. When tapped, the latent talents of the young people shall be fully developed through the skills training, turning them into dynamic agents of positive change.

The bill therefore seeks to make TESDA replicable in barangay Apulid, in the municipality of Paniqui, Tarlac, which shall also serve 34 other barangays.

The urgent passage of this bill is then most prayed for.

**AN ACT**  
**ESTABLISHING THE PANQUI TARLAC TECHNICAL EDUCATION AND**  
**SKILLS DEVELOPMENT AUTHORITY (TESDA) TRAINING CENTER AND**  
**APPROPRIATING FUNDS THEREFOR**

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

SECTION 1. *Establishment of the Technical Education and Skills Development Authority (TESDA) Training Center.* – There is hereby established, under the supervision of the Technical Education and Skills Development Authority a training center in Apulid, Paniqui, Tarlac to be known as the Paniqui Tarlac Technical Education and Skills Development Authority (TESDA) Training Center.

SEC. 2. *Appropriations.* – The amount necessary for the operationalization of the Paniqui Tarlac Technical Education and Skills Development Authority Training Center shall be included in the current year's General Appropriations Act. Thereafter, such amount as may be necessary for its continued implementation shall be included in the annual General Appropriations Act.

SEC. 3. *Implementation.* – Within sixty (60) days, the Secretary of Education shall issue the rules and regulations as may be necessary to carry out the provisions of this Act.

SEC. 4. *Effectivity.* – This Act shall take effect fifteen (15) days after its publication in the Official Gazette.
