AN ACT ESTABLISHING AN ELEMENTARY SCHOOL IN BARANGAY TIGUNHAO, MUNICIPALITY OF LAUA-AN, PROVINCE OF ANTIQUE, TO BE KNOWN AS TIGUNHAO ELEMENTARY SCHOOL, APPROPRIATING FUNDS THEREFOR

Explanatory Note

This bill seeks to establish an elementary school in Barangay Tigunhao, Municipality of Laua-an in the Lone District of Antique to be known as the Tigunhao Elementary School.

Currently, there is an existing primary school in Barangay Tigunhao, but the school is not able to cater to full primary education. Thus, school children still need to travel to neighboring barangays to fulfill primary education requirements.

As highlighted in the Child and Welfare Code of the Philippines Article 3 paragraph 6, "Every child has the right to an education commensurate with his abilities and to the development of his skills for the improvement of his capacity for service to himself and to his fellowmen." Education is a fundamental human right. Let not one child be deprived of the opportunity to learn, develop and allow them to be part of the country's aim for inclusive growth.

In view of the foregoing, the immediately passage of this bill is earnestly sought.

HOUSE BILL NO. 511

AN ACT ESTABLISHING AN ELEMENTARY SCHOOL IN BARANGAY TIGUNHAO, MUNICIPALITY OF LAUA-AN, PROVINCE OF ANTIQUE, TO BE KNOWN AS TIGUNHAO ELEMENTARY SCHOOL, APPROPRIATING FUNDS THEREFOR

Be it enacted in the Senate and House of Representatives of the Philippines in Congress assembled:

- 1 SECTION 1. There is hereby established, under the supervision of the Department
- of Education, an elementary school in Barangay Tigunhao, Municipality of Laua-an in
- 3 the Province of Antique to be known as Tigunhao Elementary School
- 4 SEC. 2. The Secretary of Education shall immediately include in the Department's
- 5 program the operationalization of the Tigunhao Elementary School, the funding of
- 6 which shall be included in the annual General Appropriations Act.
- 7 SEC. 3. The Secretary of Education shall formulate the rules and regulations
- 8 implementing the provisions of this Act within one hundred twenty (120) days after its
- 9 effectivity.
- 10 SEC. 4. This Act shall take effect fifteen (15) days after its publication in the Official
- 11 Gazette or in a newspaper of general circulation.
