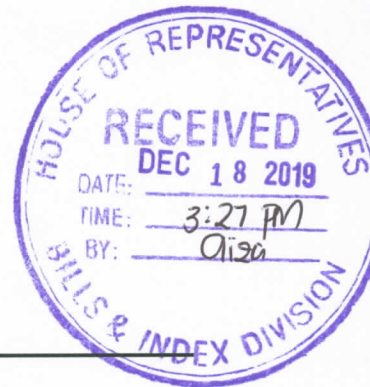

AN ACT

UPGRADING THE MARIA L. ELEAZAR DISTRICT HOSPITAL IN THE MUNICIPALITY OF TAGKAWAYAN, PROVINCE OF QUEZON INTO A LEVEL III GENERAL HOSPITAL, TO BE KNOWN AS THE MARIA L. ELEAZAR GENERAL HOSPITAL, UNDER THE DIRECT SUPERVISION AND CONTROL OF THE DEPARTMENT OF HEALTH, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. The Maria L. Eleazar District Hospital in the Municipality of Tagkawayan,
2 Province of Quezon is hereby upgraded into a Level III general hospital to be known as the
3 Maria L. Eleazar General Hospital, under the direct supervision and control of the Department
4 of Health (DOH).

6 The bed capacity of the Maria L. Eleazar General Hospital in the Municipality of
7 Tagkawayan, Province of Quezon shall be implemented in accordance with a hospital
8 development plan that shall be prepared by the DOH.

10 SEC. 2. The existing professional health care services and facilities are also hereby
11 upgraded to conform with and be commensurate to the bed capacity increase as provided in
12 Section 1 hereof.

14 SEC. 3. The Secretary of Health shall include in the Department's program the
15 implementation of this Act, the funding of which shall be included in the annual General
16 Appropriations Act.

18 SEC. 4. Within ninety (90) days from the effectivity of this Act, the Secretary of Health
19 shall prepare the implementing rules and regulations (IRR) upon consultation with the
20 Provincial Government of Quezon and other stakeholders and shall be implemented
21 consistent with the hospital development plan.

23 SEC. 5. This Act shall take effect fifteen (15) days after its publication in the *Official*
24 *Gazette* or in a newspaper of general circulation.
