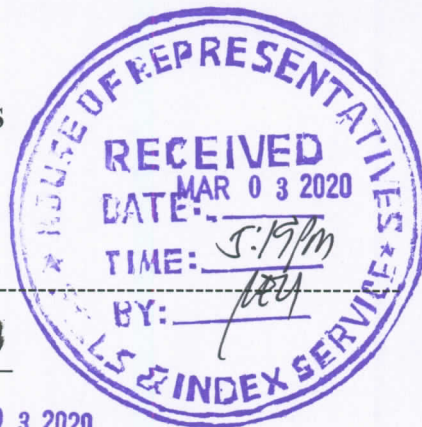

The Committee on Public Works and Highways to which was referred House Bill No. 2431, introduced by Rep. Allen Jesse C. Mangaoang, entitled:



HOUSE BILL NO. 6467
(In Substitution of House Bill No. 2431)

AN ACT
RENAMING THE PORTION OF THE MOUNTAIN PROVINCE BOUNDARY-
CALANAN-ENRILE ROAD, STRETCHING FROM THE ANTONIO CANAO BRIDGE
IN BARANGAY CALANAN, TRAVERSING THROUGH BARANGAYS BULANAO
AND IPIL, UP TO THE ALLIOG BRIDGE IN BARANGAY NAMBARAN, ALL IN THE
CITY OF TABUK IN THE PROVINCE OF KALINGA, AS MANUEL S. AGYAO
BOULEVARD

Be it enacted by the Senate and the House of Representatives in Congress assembled:

SECTION 1. The portion of the Mountain Province Boundary-Calanan-Enrile Road, stretching from the Antonio Canao Bridge in Barangay Calanan, traversing through Barangays Bulanao and Ipil, up to the Alliog Bridge in Barangay Nambaran, all in the City of Tabuk in the Province of Kalinga, is hereby renamed as Manuel S. Agyao Boulevard.

SEC. 2. The Department of Public Works and Highways shall issue the necessary rules, orders, and circulars to implement the provisions of this Act within sixty (60) days from its effectivity.

SEC. 3. This Act shall take effect fifteen (15) days after its publication in the *Official Gazette* or in a newspaper of general circulation.
