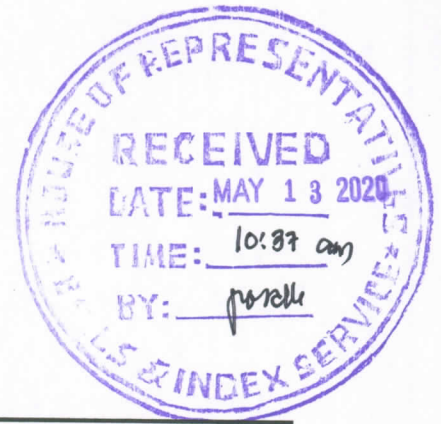

HOUSE BILL NO. 6731
(In Substitution of House Bill No. 570)

Introduced by Representative Greg G. Gasataya

AN ACT

ESTABLISHING A GENERAL HOSPITAL IN THE CITY OF BACOLOD, PROVINCE OF NEGROS OCCIDENTAL, TO BE KNOWN AS THE BACOLOD CITY GENERAL HOSPITAL, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. There shall be established a tertiary general hospital in the City of
2 Bacolod, Province of Negros Occidental to be known as the Bacolod City General Hospital
3 (BCGH).

5 SEC. 2. The City Government of Bacolod shall provide funding for the
6 establishment, operation and maintenance of the BCGH.
7

8 SEC. 3. The Chief of Hospital of the BCGH shall submit to the DOH a development
9 plan to reflect the developmental goals of the hospital. The medical personnel, capital
10 outlays and budgetary needs for the operation of the BCGH shall be based on the hospital
11 development plan.

13 SEC. 4. The Secretary of the Department of Health (DOH) shall include in the
14 Department's subsidy program, its support for the capital outlays of the hospital.

16 SEC. 5. The Secretary of Health, in consultation and coordination with local
17 government officials concerned, shall promulgate the necessary rules and regulations for the
18 effective implementation of this Act within ninety (90) days from its effectivity.
19

20 SEC. 6. This Act shall take effect fifteen (15) days after its publication in the *Official*
21 *Gazette* or in a newspaper of general circulation.
