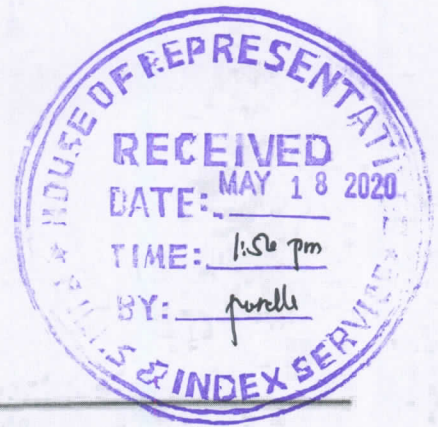

HOUSE BILL NO. 6753

(In substitution of House Bill Number 2605)

AN ACT

CONVERTING THE MEDINA EXTENSION HOSPITAL IN THE MUNICIPALITY OF MEDINA, PROVINCE OF MISAMIS ORIENTAL INTO A GENERAL HOSPITAL TO BE KNOWN AS THE FIRST MISAMIS ORIENTAL GENERAL HOSPITAL, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** The Medina Extension Hospital in the Municipality of Medina, Province of
2 Misamis Oriental is hereby converted into a general hospital to be known as the First Misamis
3 Oriental General Hospital which shall be under the direct control and supervision of the
4 Department of Health (DOH). Henceforth, the First Misamis Oriental General Hospital shall
5 cease to be an extension hospital of the Northern Mindanao Medical Center, Cagayan De Oro
6 City.

7 Any future increase in bed capacity and upgrading of health care services and facilities
8 shall be based on the hospital development plan which shall be prepared by the DOH.

10 **SEC. 2.** The Secretary of Health shall immediately include in the Department's program,
11 operation and maintenance of the First Misamis Oriental General Hospital, the initial funding of
12 which shall be charged against the current year's appropriations of the Medina Extension
13 Hospital. Thereafter, such sum as may be necessary for its continued operation shall be
14 included in the annual General Appropriations Act.

16 **SEC. 3.** The Secretary of Health shall prepare and issue the necessary rules and
17 regulations for the effective implementation of this Act consistent with the hospital development
18 plan.

20 **SEC. 4.** This Act shall take effect fifteen (15) days after its publication in the *Official*
21 *Gazette* or in a newspaper of general circulation.
