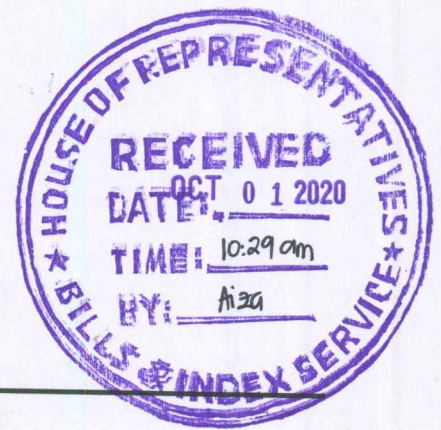

HOUSE BILL NO. 5367*

Introduced by Representative Lorna Bautista-Bandigan

AN ACT

SEPARATING THE BASIAWAN NATIONAL HIGH SCHOOL – MALAGSOM EXTENSION IN BARANGAY BUHANGIN, MUNICIPALITY OF MALITA, PROVINCE OF DAVAO OCCIDENTAL FROM THE BASIAWAN NATIONAL HIGH SCHOOL, CONVERTING IT INTO AN INDEPENDENT NATIONAL HIGH SCHOOL TO BE KNOWN AS BUHANGIN NATIONAL HIGH SCHOOL, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** The Basiawan National High School – Malagsom Extension in Barangay
2 Buhangin, Municipality of Malita, Province of Davao Occidental is hereby separated from the
3 Basiawan National High School and converted into an independent national high school to be
4 known as Buhangin National High School.

6 **SEC. 2.** All personnel, assets, liabilities and records of the Basiawan National High
7 School – Malagsom Extension are hereby transferred to and absorbed by the Buhangin National
8 High School.

10 **SEC. 3.** The Secretary of Education shall immediately include in the Department's
11 program the operationalization of the Buhangin National High School, the initial funding of
12 which shall be charged against the current year's appropriation of the Basiawan National High
13 School – Malagsom Extension. Thereafter, the amount necessary for the continued operation
14 of the school shall be included in the annual General Appropriations Act.

16 **SEC. 4.** Within one hundred twenty days (120) days after the approval of this Act, the
17 Secretary of Education shall promulgate the rules and regulations implementing the provisions
18 of this Act.

20 **SEC. 5.** This Act shall take effect fifteen (15) days after its publication in the *Official*
21 *Gazette* or in a newspaper of general circulation.
