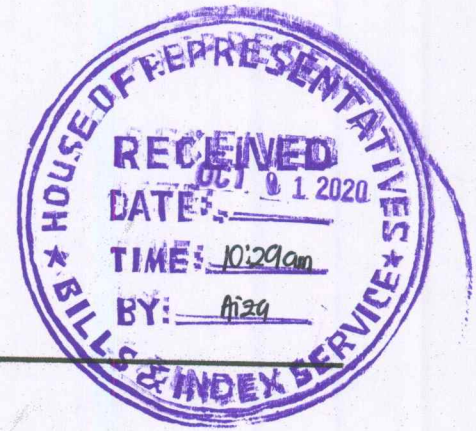



**AN ACT**

**SEPARATING THE LAWA NATIONAL HIGH SCHOOL – NUEVA VILLA EXTENSION IN BARANGAY LAWA, MUNICIPALITY OF DON MARCELINO, PROVINCE OF DAVAO OCCIDENTAL FROM THE LAWA NATIONAL HIGH SCHOOL, CONVERTING IT INTO AN INDEPENDENT NATIONAL HIGH SCHOOL TO BE KNOWN AS CORONA A. CABANILLA NATIONAL HIGH SCHOOL, AND APPROPRIATING FUNDS THEREFOR**

*Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:*

1           **SECTION 1.** The Lawa National High School – Nueva Villa Extension in Barangay  
2 Lawa, Municipality of Don Marcelino, Province of Davao Occidental is hereby separated from  
3 the Lawa National High School and converted into an independent national high school to be  
4 known as Corona A. Cabanilla National High School.

6           **SEC. 2.** All personnel, assets, liabilities and records of the Lawa National High School  
7 – Nueva Villa Extension are hereby transferred to and absorbed by the Corona A. Cabanilla  
8 National High School.

10          **SEC. 3.** The Secretary of Education shall immediately include in the Department's  
11 program the operationalization of the Corona A. Cabanilla National High School, the initial  
12 funding of which shall be charged against the current year's appropriation of the Lawa National  
13 High School – Nueva Villa Extension. Thereafter, the amount necessary for the continued  
14 operation of the school shall be included in the annual General Appropriations Act.  
15

16          **SEC. 4.** Within one hundred twenty days (120) days after the approval of this Act, the  
17 Secretary of Education shall promulgate the rules and regulations implementing the provisions  
18 of this Act.  
19

20          **SEC. 5.** This Act shall take effect fifteen (15) days after its publication in the *Official*  
21 *Gazette* or in a newspaper of general circulation.
