1 AN ACT  
2 INSTITUTIONALIZING THE CONDUCT OF SUMMER YOUTH CAMP IN  
3 EVERY BARANGAY AND APPROPRIATING FUNDS THEREFOR

4 *Be it enacted by the Senate and House of Representatives of the Philippines in Congress*  
5 *assembled:*

6 **SECTION 1. Short Title.** - This Act shall be known as the "Summer Youth Camp  
7 Act".

8 **SEC.2. Declaration of Policy.** - Article II, Section 13 of the Constitution provides  
9 that the State recognizes the vital role of the youth in nation-building and shall promote  
10 and protect their physical, moral, spiritual, intellectual, and social well-being. It shall  
11 inculcate in the youth patriotism and nationalism, and encourage their involvement in  
12 public and civic affairs.

13 Pursuant to the aforementioned mandate, it is incumbent upon the State to  
14 inculcate in the youth the values of patriotism and service to others through programs  
15 that are designed to develop in them leadership skills, a sense of responsibility and  
16 stewardship of the environment, a dutiful awareness of their role in the building of safe  
17 communities, a love for sports and an appreciation of the importance of pursuing a  
18 healthy lifestyle.

19 **SEC. 3. Summer Youth Camp.** – A summer youth camp shall be conducted in  
20 every barangay in venues chosen by the *Sangguniang Kabataan (SK)* of the  
21 respective local government unit to inculcate a sense of social responsibility, ingrain  
22 patriotism in the consciousness of the youth, develop youth leadership, engage in  
23 livelihood and entrepreneurship activities, and promote active participation in sports.

24 **SEC. 4. The Role of the Sangguniang Kabataan.** - The SK shall spearhead the  
25 planning, implementation, monitoring, and evaluation of the summer youth camps in  
26 their respective jurisdictions. The SK shall perform the following:

- 27 (a) Choose the venue for the summer youth camp;
- 28 (b) Coordinate with concerned institutions such as the National Youth  
29 Commission (NYC), Department of the Interior and Local Government  
30 (DILG), Department of Trade and Industry (DTI), Department of Health  
31 (DOH), Department of Information and Communications Technology  
32 (DICT), Philippine Sports Commission (PSC), National Commission on  
33 Culture and the Arts (NCCA), Department of Tourism (DOT), and other  
34 concerned youth organizations and youth-serving organizations;

- 1 (c) Engage qualified trainers, in consultation with the representatives from  
2 local educational institutions, who shall teach the youth the topics included  
3 in the courses provided for in Section 5 of this Act;
- 4 (d) Monitor the whole program and provide a report to be reviewed by the  
5 Local Youth Development Office; and
- 6 (e) Evaluate the program, identify areas for improvement, and submit  
7 proposals to the NYC.

8 **SEC. 5. Courses.-** The NYC, SK, representatives from the local educational  
9 institutions, the Local Development Youth Office, in close consultation with the  
10 Katipunan ng Kabataan, shall develop modules on the following courses:

- 11 (a) National situationer on issues and current events impacting the youth;
- 12 (b) Leadership seminar on communication and teambuilding, conflict  
13 management, safe and inclusive environments, decision-making, healthy  
14 leadership, and parliamentary procedures;
- 15 (c) Writing workshop on creative writing workshop, conference and seminars  
16 on research, editing, illustration, and publication;
- 17 (d) Public speaking on interpersonal communication, motivational speeches,  
18 persuasive speaking, technical presentations, public relations, debate,  
19 and group discussions;
- 20 (e) Sports and fitness that shall include strengthening and conditioning,  
21 physical education, competitive sports, indigenous games, sports  
22 coaching, and psychology;
- 23 (f) Mental wellness related to mental issues, youth pregnancy, and other  
24 challenges facing the youth;
- 25 (g) Digital skills development, including training for the use of virtual  
26 applications and responsible use of social media;
- 27 (h) Entrepreneurship and livelihood skills training applicable for both rural and  
28 urban setting; and
- 29 (i) Cultural awareness to foster culture-based empowerment, leadership,  
30 and governance among the youth.

1           **SEC. 6. Assistance of Concerned Government Agencies, Organizations,**  
2 **and Instrumentalities.-** The NYC, DILG, DTI, DOH, DICT, PSC, NCCA, DOT, and  
3 other concerned agencies, shall provide the necessary assistance to the SK for the  
4 effective implementation of the summer youth camp.

5           **SEC. 7. Funding.-** The budget for the Summer Youth Camp shall be included  
6 in the annual appropriations of the SK of the respective local government units in  
7 accordance with Section 20 (a) of R.A. No. 10742, otherwise known as the  
8 “Sangguniang Kabataan Reform Act of 2015.”

9           **SEC. 8. Implementing Rules and Regulations.-** The NYC, the DILG, the SK  
10 representatives shall, in consultation with various youth organizations and youth-  
11 serving organizations, promulgate the rules and regulations to implement the  
12 provisions of this Act within sixty (60) days after its effectivity.

13           **SEC. 9. Separability Clause.-** If any part or provision of this Act is held invalid  
14 or unconstitutional, the other provisions not affected shall remain in full force and  
15 effect.

16           **SEC. 10. Repealing Clause. -** All laws, executive orders, issuances, decrees,  
17 rules, and regulations, inconsistent with or contrary to the provisions of this Act are  
18 deemed amended, modified or repealed accordingly.

19           **SEC. 11. Effectivity.-** This Act shall take effect fifteen (15) days after its  
20 publication in the *Official Gazette* or in a newspaper of general circulation.

**OBJECTIVE:**

- To empower the youth and inculcate in them a sense of social responsibility by providing training modules on leadership skills, livelihood and entrepreneurship activities, personal development, and promote their active participation in sports.

**KEY PROVISIONS:**

- Conducts summer youth camp in every barangay in venues chosen by the *Sangguniang Kabataan* (SK) of the respective local governments;
- Mandates the SK to spearhead the planning, implementation, monitoring, and evaluation of the summer youth camps in their respective jurisdictions;
- Develops course modules on national situationer, leadership seminar, writing workshop, public speaking, sports and fitness, mental wellness, digital skills, entrepreneurship, livelihood, and cultural awareness;
- Directs the National Youth Commission, Department of the Interior and Local Government, Department of Trade and Industry, Department of Health, Department of Information and Communications Technology, Philippine Sports Commission, National Commission on Culture and the Arts to provide the necessary assistance to the SK; and

- Includes in the annual appropriations of the *Sangguniang Kabataan* of the respective local government units the budget for the Summer Youth Camp.
