**INTRODUCED BY REPRESENTATIVES EMMARIE “LOLYPOP” OUANO-
DIZON, ELEANDRO JESUS F. MADRONA AND ERIC GO YAP**

AN ACT
PROVIDING FOR THE TRI-LEVEL INTERCHANGE ALONG M.C.
BRIONES STREET CORNER U.N. AVENUE, MANDAUE CITY,
PROVINCE OF CEBU AND
APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

1 **Section 1.** There shall be constructed under the supervision of the Department of Public
2 Works and Highways (DPWH), a Tri-Level Interchange along M.C. Briones Street corner U.N.
3 Avenue, Mandaue City, Province of Cebu.

4 **Sec. 2.** The amount necessary to defray the cost of undertaking and completing the
5 feasibility study and detailed engineering design for this project and other activities related thereto
6 shall be included in the General Appropriations Act (GAA). Thereafter, the Secretary of DPWH
7 shall include in the Department’s program the construction of said road, the funding of which shall
8 be included in the GAA.

9 **Sec. 3.** This Act shall take effect fifteen (15) days after its publication in the *Official*
10 *Gazette* or in any newspaper of general circulation.
