The Committees on Justice and Appropriations, to which was referred House Bill No. 7201, introduced by Representative Michael B. Gorriceta, entitled:

"AN ACT

CREATING TWO (2) ADDITIONAL MUNICIPAL TRIAL COURTS, ONE (1) MUNICIPAL TRIAL COURT FOR STA. BARBARA, AND ONE (1) MUNICIPAL TRIAL COURT IN PAVIA, ALL SITUATED IN THE PROVINCE OF ILOILO, IN THE SIXTH JUDICIAL REGION, THUS AMENDING FOR THE PURPOSE BATAS PAMBANSA BLG. 129, OTHERWISE KNOWN AS "THE JUDICIARY REORGANIZATION ACT OF 1980", AS AMENDED, AND APPROPRIATING FUNDS THEREFOR"

AN ACT

CREATING TWO (2) ADDITIONAL BRANCHES OF THE MUNICIPAL TRIAL COURT IN THE SIXTH JUDICIAL REGION TO BE STATIONED IN THE MUNICIPALITIES OF STA. BARBARA AND PAVIA, PROVINCE OF ILOILO, AND APPROPRIATING FUNDS THEREFOR, AMENDING FOR THE PURPOSE SECTION 30 OF BATAS PAMBANSA BLG. 129, AS AMENDED, OTHERWISE KNOWN AS 'THE JUDICIARY REORGANIZATION ACT OF 1980'

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** Two (2) additional branches of the Municipal Trial Court in the Sixth
2 Judicial Region are hereby created and stationed in the Municipalities of Sta. Barbara
3 and Pavia, Province of Iloilo.

4
5 The Supreme Court shall assign the respective branch numbers for the newly
6 created branches of the Municipal Trial Court.

7
8 **SEC. 2.** The Chief Justice of the Supreme Court, in coordination with the Secretary
9 of the Department of Justice, shall immediately include in the Court's program the
10 operationalization of the additional branches of the Municipal Trial Court in the
11 Municipalities of Sta. Barbara and Pavia, Province of Iloilo. The funds necessary for the
12 operation of the courts herein created shall be appropriated and released only upon the

1 actual organization of the courts and the appointment of its personnel.

2
3 **SEC. 3.** Section 30 of Batas Pambansa Blg. 129, as amended, otherwise known as
4 "The Judiciary Reorganization Act of 1980", and all other laws, rules and regulations
5 which are inconsistent with this Act are hereby amended, repealed or modified
6 accordingly.

7
8 **SEC. 4.** This Act shall take effect fifteen (15) days after its publication in the *Official*
9 *Gazette* or in a newspaper of general circulation.

OBJECTIVE:

- To ensure the speedy disposition of cases and to declog court dockets.

KEY PROVISIONS:

- Creates two (2) additional branches of the Municipal Trial Court (MTC) in the Sixth Judicial Region to be stationed in the Municipalities of Sta Barbara and Pavia, Province of Iloilo
- Mandates that the funds for the operation of the additional MTC shall be appropriated and released only upon the actual organization of the court and the appointment of its personnel.
