AN ACT
**RENAMING THE URDANETA CITY BYPASS ROAD, TRAVERSING BARANGAYS
NANCAYASAN, SANTO DOMINGO, SANTA LUCIA, CAMANTILES, AND ANONAS IN
THE CITY OF URDANETA, PROVINCE OF PANGASINAN, AS EDUARDO COJUANGCO
JR. AVENUE**

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

- 1 **SECTION 1.** The Urdaneta City Bypass Road, traversing Barangays Nancayasan , Santo Domingo,
2 Santa Lucia, Camantiles, and Anonas in the City of Urdaneta, Province of Pangasinan, comprising a total
3 distance of 7.17 kilometers, is hereby renamed as Eduardo Cojuangco Jr. Avenue
- 4 **SEC. 2.** The Department of Public Works and Highways shall issue the necessary rules, orders, and
5 circulars to implement the provisions of this Act within sixty (60) days from its effectivity.
- 6 **SEC. 3.** This Act shall take effect fifteen (15) days after its publication in the *Official Gazette* or in a
7 newspaper of general circulation.
