**UNFINISHED BUSINESS:
COMMITTEE REPORT NO. 47
ON HOUSE BILL NO. 4727**

On motion of Rep. Defensor, there being no objection, the Body resumed consideration on Second Reading of House Bill No. 4727, as embodied in Committee Report No. 47 and reported out by the Committee on Justice.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

“AN ACT IMPOSING THE DEATH PENALTY ON CERTAIN HEINOUS CRIMES, REPEALING FOR THE PURPOSE REPUBLIC ACT NO. 9346, ENTITLED ‘AN ACT PROHIBITING THE IMPOSITION OF DEATH PENALTY IN THE PHILIPPINES,’ AND AMENDING ACT NO. 3815, AS AMENDED, OTHERWISE KNOWN AS THE ‘REVISED PENAL CODE,’ AND OTHER SPECIAL PENAL LAWS.”

Rep. Defensor stated that the parliamentary status was that the Bill was in the period of sponsorship and debate; and on his motion, the Chair recognized Rep. Fredenil “Fred” H. Castro to sponsor the same and Rep. Tom S. Villarín to interpellate thereon.

INTERPELLATION OF REP. VILLARIN

Initially, Rep. Villarín relayed the AKBAYAN Party-List’s belief that (1) the State should not deprive a person of the supreme right to life and (2) the death penalty was morally, socially, and politically wrong; contravened international laws and standards; was often arbitrary especially against the poor and powerless and was too irrevocable; had no deterrent effect on crime; and could be abused to target particular social groups or political opponents.

He first asked on the moral and constitutional basis and justification of the death penalty as he stressed the lack of data on its deterrent effect on crime and as he cited statistics, international reports, and pronouncements of world leaders on the proliferation of illegal drugs despite the imposition of the death penalty. Rep. Castro (F.H.) explained that the Constitution did not require a surge of heinous crimes for Congress to exercise its plenary power to legislate on the death penalty; and the reimposition of the latter was not based on any moral compulsion but on the task of the State to deliver justice.

He then asked if the death penalty was mandatory, opining that such was highly arbitrary and illegal and had no place in a modern and civilized society. Rep. Castro however clarified that the Sponsors wanted to do away with a mandatory death penalty and the measure will give the courts the option to impose the death penalty or *reclusion perpetua* for the heinous crimes enumerated therein.

Rep. Villarín thereafter urged the government to look beyond addressing the drug menace as just a law enforcement issue and treat drug offenders as human addicts who could reform. He also explained the bias of capital punishment on poor and disabled prisoners who could not adequately defend themselves and afford good lawyers, and cited the fact that 71.7 percent of death penalty convictions were reversed by the Supreme Court. He likewise pointed out that the reimposition of the death penalty would violate international treaty obligations and affect the country’s Generalized System of Preference Plus (GSP+) status with the European Union, thus resulting in the loss of jobs in agriculture and manufacturing and billions of dollars in bilateral trade.

Rep. Castro explained that the word “deterrence” was never mentioned in the Constitution and the proponents of the death penalty did not want the State to be left defenseless against crime. He also invoked the answers of the previous Sponsors, in response to Rep. Villarín’s concerns.

MOTION OF REP. ATIENZA

At this point, Rep. Atienza moved to adjourn the session because there were not enough Members present.

SECONDING MOTION OF MAJORITY LEADER FARIÑAS

Rep. Rodolfo C. Fariñas said that he would normally object to a motion to adjourn because he wanted the people in the gallery to be given the opportunity to listen to the arguments on the instant measure; but that he was seconding the motion of Senior Deputy Minority Leader Atienza in deference to him.

ADJOURNMENT OF SESSION

There being no objection, the Chair thus declared the session adjourned until four o’clock in the afternoon of Wednesday, February 22, 2017.
