AN ACT SEPARATING SITIO PANACAN-2 FROM BARANGAY PANACAN IN THE MUNICIPALITY OF NARRA, PROVINCE OF PALAWAN AND CONSTITUTING IT INTO A SEPARATE AND INDEPENDENT BARANGAY TO BE KNOWN AS BARANGAY PANACAN-2

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. *Creation of Barangay Panacan-2.* – Sitio
2 Panacan-2 is hereby separated from Barangay Panacan in the
3 Municipality of Narra, Province of Palawan to constitute a separate
4 and independent barangay to be known as Barangay Panacan-2.

5 SEC. 2. *Territorial Boundaries.* – The territorial boundaries
6 of Barangay Panacan-2 shall be described as follows:

7 “Bounded on the Northwest along lines 1, 2, 3, 4, 5, 6, 7, 8 and
8 9 by National Highway 60.0 meters wide; on the Northeast along
9 lines 9, 10, 11 and 12 by Lot 8035, Cad 797-D Narra Cadastre and
10 Barangay Antipuluan; on the Southeast along lines 12, 13, 14, 15,
11 16, 17, 18, 19, 20, 21 and 22 by Sulu Sea and lines 22, 23, 24, 25 and
12 26 by Lot Cad 797-D Narra Cadastre and on the South along lines

1 29, 30, 31, 32, 33, 34, 35, 36, 37, 38, 39, 40 and 1 by Barangay
2 Panacan center line of existing Provincial Road.”
3 “Beginning at the point marked “1” on plan being S.48’ 35’ W;
4 2,069.48 meters from BLLM No. 1 Cad 797-D Narra Cadastre;

 20 SEC. 3. *Conduct and Supervision of Plebiscite.* – The
 21 plebiscite conducted and supervised by the Commission on Elections
 22 (COMELEC) pursuant to *Sangguniang Panlalawigan ng Palawan*
 23 Provincial Ordinance No. 935, Series of 2006, as amended, which
 24 was duly ratified and proclaimed by the Plebiscite Board of
 25 Canvassers on December 16, 2006, shall serve as substantial
 26 compliance with the plebiscite requirement under Section 10 of
 27 Republic Act No. 7160, as amended, otherwise known as the Local
 28 Government Code of 1991.

1 SEC. 4. *Barangay Officials.* – The incumbent elected
 2 barangay officials of the said barangay shall hold office in Barangay
 3 Panacan-2 until such time that a new set of officers have been duly
 4 elected and qualified.

5 SEC. 5. *Public Infrastructure and Facilities.* – All public
 6 infrastructure and facilities existing therein at the time of the
 7 approval of this Act are hereby transferred without cost or
 8 compensation to and shall be administered by the new barangay.

9 SEC. 6. *Internal Revenue Allotment Shares.* – Barangay
 10 Panacan-2 shall be entitled to Internal Revenue Allotment (IRA)
 11 shares pursuant to Section 285 of the Local Government Code of
 12 1991, as amended.

13 SEC. 7. *Repealing Clause.* – All laws, decrees, executive
 14 orders, rules and regulations, which are inconsistent with this Act
 15 are hereby amended, repealed or modified accordingly.

16 SEC. 8. *Effectivity.* – This Act shall take effect fifteen (15)
 17 days after its publication in the *Official Gazette* or in a newspaper of
 18 general circulation.
