AN ACT CREATING A BARANGAY TO BE KNOWN AS
BARANGAY NORTH DAANG HARI IN THE CITY OF
TAGUIG, METROPOLITAN MANILA

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. *Creation of Barangay North Daang Hari.* –
2 North Daang Hari in Barangay Bagong Tanyag, City of Taguig,
3 Metropolitan Manila is hereby separated from Barangay Bagong
4 Tanyag and constituted into a distinct and independent barangay to
5 be known as Barangay North Daang Hari.

6 SEC. 2. *Territorial Boundaries.* – The territorial boundaries
7 of Barangay North Daang Hari are hereby described as follows:

8 “Bounded on the North by General Santos Avenue;

9 On the East by Case 14 590-D, Taguig Cadastral Mapping
10 (Barangay Bagumbayan), P.U.P. Compound, Sta. Maria Industrial
11 Subdivision and the Manila Railroad Company (Railroad Tract);

12 On the South by Mañalac Avenue; and

13 On the West by Parañaque Cadastre.”

1 SEC. 3. *Conduct and Supervision of Plebiscite.* – The
2 plebiscite conducted and supervised by the Commission on Elections
3 (COMELEC) in Barangay Bagong Tanyag pursuant to City
4 Ordinance No. 27, Series of 2008 of the Sangguniang Panlungsod of
5 the City of Taguig, which ratified the creation of Barangay North
6 Daang Hari as proclaimed by the City Board of Canvassers on
7 December 28, 2008, shall serve as substantial compliance with the
8 plebiscite requirement under Section 10 of Republic Act No. 7160,
9 as amended, otherwise known as the “Local Government Code of
10 1991”.

11 SEC. 4. *Incumbent Barangay Officials.* – The incumbent
12 barangay officials of Barangay North Daang Hari, City of Taguig
13 shall continue to hold office until such time that their successors
14 have been duly elected and qualified.

15 SEC. 5. *Public Infrastructure and Facilities.* – All public
16 infrastructure and facilities existing therein at the time of the
17 approval of this Act are hereby transferred without cost or
18 compensation to and shall be administered by the new barangay.

19 SEC. 6. *Internal Revenue Allotment Shares.* – Barangay
20 North Daang Hari shall be entitled to the Internal Revenue
21 Allotment (IRA) shares pursuant to Section 285 of the Local
22 Government Code of 1991, as amended.

23 SEC. 7. *Effectivity.* – This Act shall take effect fifteen (15)
24 days after its publication in the *Official Gazette* or in a newspaper of
25 general circulation.
