AN ACT CREATING A BARANGAY TO BE KNOWN AS BARANGAY  
CENTRAL BICUTAN IN THE CITY OF TAGUIG

*Be it enacted by the Senate and House of Representatives of the  
Philippines in Congress assembled:*

1 SECTION 1. *Creation of Barangay Central Bicutan.* – The  
2 Central Bicutan Proper in Barangay Upper Bicutan, City of Taguig  
3 is hereby separated from Barangay Upper Bicutan and constituted  
4 into a distinct and independent barangay to be known as Barangay  
5 Central Bicutan.

6 SEC. 2. *Territorial Boundaries.* – The territorial boundaries  
7 of Barangay Central Bicutan are hereby described as follows:

8 “Bounded on the Northeast and East by a creek and  
9 Maharlika Road, Lapu-Lapu Street and Bonifacio Street;

10 On the South by Bonifacio Street; and

11 On the West and Northwest by F.T.I. Compound and  
12 Parañaque Cadastre.”

13 SEC. 3. *Conduct and Supervision of Plebiscite.* – The  
14 plebiscite conducted and supervised by the Commission on Elections  
15 (COMELEC) in Barangay Upper Bicutan pursuant to City  
16 Ordinance No. 57, Series of 2008 of the Sangguniang Panlungsod of

1 the City of Taguig, which ratified the creation of Barangay Central  
2 Bicutan as proclaimed by the City Board of Canvassers on  
3 December 28, 2008, shall serve as substantial compliance with the  
4 plebiscite requirement under Section 10 of Republic Act No. 7160,  
5 as amended, otherwise known as the “Local Government Code  
6 of 1991”.

7 SEC. 4. *Incumbent Barangay Officials.* – The incumbent  
8 barangay officials of Barangay Central Bicutan, City of Taguig shall  
9 continue to hold office until such time that their successors have  
10 been duly elected and qualified.

11 SEC. 5. *Public Infrastructure and Facilities.* – All public  
12 infrastructure and facilities existing therein at the time of the  
13 approval of this Act are hereby transferred without cost or  
14 compensation to and shall be administered by the new barangay.

15 SEC. 6. *Internal Revenue Allotment Shares.* – Barangay  
16 Central Bicutan shall be entitled to Internal Revenue Allotment  
17 (IRA) shares pursuant to Section 285 of the Local Government Code  
18 of 1991.

19 SEC. 7. *Effectivity.* – This Act shall take effect fifteen (15)  
20 days after its publication in the *Official Gazette* or in a newspaper of  
21 general circulation.
