AN ACT CREATING A BARANGAY TO BE KNOWN AS  
BARANGAY NORTH SIGNAL VILLAGE IN THE CITY  
OF TAGUIG

*Be it enacted by the Senate and House of Representatives of the  
Philippines in Congress assembled:*

1 SECTION 1. *Creation of Barangay North Signal Village.* –  
2 North Signal Village Proper in Barangay Signal Village, City of  
3 Taguig is hereby separated from Barangay Signal Village and  
4 constituted into a distinct and independent barangay to be known  
5 as Barangay North Signal Village.

6 SEC. 2. *Territorial Boundaries.* – The territorial boundaries  
7 of Barangay North Signal Village are hereby described as follows:

8 “Bounded on the North by the property of the Bases  
9 Conversion and Development Authority (BCDA-Palakol Area and  
10 Pinagsama Village Phase II);

11 On the South by M.R.T. Avenue (formerly Cuasay Street);

12 On the East by the property of BCDA (Palakol Area-Pag-asa)  
13 and Dream Land Village; and

1 On the West by E.P. Housing Village Phase 2, Sampaloc  
2 Street and a creek.”

3 SEC. 3. *Conduct and Supervision of Plebiscite.* – The  
4 plebiscite conducted and supervised by the Commission on Elections  
5 (COMELEC) in Barangay Signal Village pursuant to City  
6 Ordinance No. 58, Series of 2008 of the Sangguniang Panlungsod of  
7 the City of Taguig, which ratified the creation of Barangay North  
8 Signal Village as proclaimed by the City Board of Canvassers on  
9 December 28, 2008, shall serve as substantial compliance with the  
10 plebiscite requirement under Section 10 of Republic Act No. 7160,  
11 as amended, otherwise known as the “Local Government Code of  
12 1991”.

13 SEC. 4. *Incumbent Barangay Officials.* – The incumbent  
14 barangay officials of Barangay North Signal Village, City of Taguig  
15 shall continue to hold office until such time that their successors  
16 have been duly elected and qualified.

17 SEC. 5. *Public Infrastructure and Facilities.* – All public  
18 infrastructure and facilities existing therein at the time of the  
19 approval of this Act are hereby transferred without cost or  
20 compensation to and shall be administered by the new barangay.

21 SEC. 6. *Internal Revenue Allotment Shares.* – Barangay  
22 North Signal Village shall be entitled to Internal Revenue  
23 Allotment (IRA) shares pursuant to Section 285 of the Local  
24 Government Code of 1991.

25 SEC. 7. *Effectivity.* – This Act shall take effect fifteen (15)  
26 days after its publication in the *Official Gazette* or in any newspaper  
27 of general circulation.
