AN ACT CREATING A BARANGAY TO BE KNOWN AS BARANGAY  
KATUPARAN IN THE CITY OF TAGUIG

*Be it enacted by the Senate and House of Representatives of the  
Philippines in Congress assembled:*

1 SECTION 1. *Creation of Barangay Katuparan.* – Katuparan  
2 Proper in Barangay Signal Village, City of Taguig is hereby  
3 separated from Barangay Signal Village and constituted into a  
4 distinct and independent barangay to be known as Barangay  
5 Katuparan.

6 SEC. 2. *Territorial Boundaries.* – The territorial boundaries  
7 of Barangay Katuparan are hereby described as follows:

8 “Bounded on the North by Pamayanang Diego Silang and  
9 Pinagsama Village Phase 2;

10 On the South by Barangay Signal Village (Proclamation  
11 No. 172) Psd-13-02057;

12 On the East by NAPOCOR High Tension Line; and

13 On the West by HHSG and Barangay Signal Village  
14 (Proclamation No. 172).”

15 SEC. 3. *Conduct and Supervision of Plebiscite.* – The  
16 plebiscite conducted and supervised by the Commission on Elections

1 (COMELEC) in Barangay Signal Village pursuant to City  
2 Ordinance No. 59, Series of 2008 of the Sangguniang Panlungsod of  
3 the City of Taguig, which ratified the creation of Barangay  
4 Katuparan as proclaimed by the City Board of Cavassers on  
5 December 28, 2008, shall serve as substantial compliance with the  
6 plebiscite requirement under Section 10 of Republic Act No. 7160,  
7 as amended, otherwise known as the “Local Government Code of  
8 1991”.

9 SEC. 4. *Incumbent Barangay Officials.* – The incumbent  
10 barangay officials of Barangay Katuparan, City of Taguig shall  
11 continue to hold office until such time that their successors have  
12 been duly elected and qualified.

13 SEC. 5. *Public Infrastructure and Facilities.* – All public  
14 infrastructure and facilities existing therein at the time of the  
15 approval of this Act are hereby transferred without cost or  
16 compensation to and shall be administered by the new barangay.

17 SEC. 6. *Internal Revenue Allotment Shares.* – Barangay  
18 Katuparan shall be entitled to Internal Revenue Allotment (IRA)  
19 shares pursuant to Section 285 of the Local Government Code of  
20 1991, as amended.

21 SEC. 7. *Effectivity.* – This Act shall take effect fifteen (15)  
22 days after its publication in the *Official Gazette* or in a newspaper of  
23 general circulation.
