AN ACT CREATING THREE (3) ADDITIONAL BRANCHES OF THE REGIONAL TRIAL COURT IN THE FOURTH JUDICIAL REGION TO BE STATIONED IN THE CITY OF GENERAL TRIAS, PROVINCE OF CAVITE, AND APPROPRIATING FUNDS THEREFOR, AMENDING FOR THE PURPOSE SECTION 14(E) OF BATAS PAMBANSA BLG. 129, OTHERWISE KNOWN AS "THE JUDICIARY REORGANIZATION ACT OF 1980", AS AMENDED

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. Three (3) additional branches of the Regional Trial
2 Court in the Fourth Judicial Region are hereby created and
3 stationed in the City of General Trias, Province of Cavite.
4 The Supreme Court shall assign the respective branch
5 numbers for the newly created branches of the Regional Trial Court.

1 SEC. 2. The Chief Justice of the Supreme Court, in
2 coordination with the Secretary of the Department of Justice, shall
3 immediately include in the Court's program the operationalization
4 of the three (3) additional branches of the Regional Trial Court in
5 the City of General Trias, Province of Cavite, the funding of which
6 shall be included in the annual General Appropriations Act.

7 SEC. 3. Section 14(e) of Batas Pambansa Blg. 129, otherwise
8 known as "The Judiciary Reorganization Act of 1980", as amended,
9 and all other laws, rules and regulations which are inconsistent
10 with this Act are hereby amended, repealed or modified accordingly.

11 SEC. 4. This Act shall take effect fifteen (15) days after its
12 publication in the *Official Gazette* or in a newspaper of
13 general circulation.
